

From the Pastor's Desk

The tide was coming in as we walked down the beach. As it did, the water relentlessly attacked the sand on the beach, trying to overcome the dryness of the land as well as the height of the dunes. The waves would rush over or around the high spots, yet as the water receded, rivulets of water that had made it over the dune would rush back out in the low spots to rejoin the gulf. I thought – why rush back if you were trying to overcome the beach? Once you got there, wouldn't you stay?

I thought of how this may represent the mission of the church. If the gulf represented the immense love of God – that love that sent Jesus to die and redeem the world -- that love that not even death can separate us from, and this love of God is constantly trying to woo the world, to reach the lost, to minister to the hurting, to bring all mankind to the saving grace of Christ, then we the Christians should be pushing forward into the dark places of the world with that love the way the gulf sends its waters onto the beach.

We -- the church -- should be taking God's love into the world that is a lost and dry place. We try to bring life and joy and peace to those in need, yet we, like that water, need to return to God's love in order to be recharged, renewed and refreshed so that we can go out into the highways and byways of life to once again share God's love. That is one purpose of worship – to reenergize the saints for the work of the kingdom.

Like the tide and the waves which come again and again, day after day, God's love comes again and again, over and over, never ceasing, never ending, ever crashing over us like the waves that crash on the beach. God is constantly striving to reach those who are out of relationship with Him. This constant rolling love is His prevenient grace trying to woo us to Him.

The rivulets rushing back to the sea could be those people that God's love has touched being united to His body through His justifying grace. Then as the water rejoins the main body and is renewed, it is likened to God's sanctifying grace which leads us into a mature life and guides us on our journey as we allow more and more of Jesus to control our lives and become like Him, ready to pour ourselves out for those in need. Just as the Gulf of Mexico is almost limitless in the amount of water it holds, God's love is limitless. Just as the tide never ceases, we should never cease to present the love of God to the world.

First Corinthians 12:4-8 "Love is patient and kind; love does not envy or boast; it is not arrogant or rude. It does not insist on its own way; it is not irritable or resentful; it does not rejoice at wrong-doing, but rejoices with the truth. Love bears all things, believes all things, hopes all things, endures all things."

2015 Mission Trip in Review

An open letter from Lee Mueller, Youth Director

Dear Church Family,

First I'd like to thank you all for your support to make these experiences possible! The Gatlinburg TeamEffort Mission Trip—which ironically was about an hour from Gatlinburg and we didn't set foot in the city—was based at The King's Academy in Seymour, TN. The King's Academy is a private school for PreK through high school. The high-school students are mostly internationals who live on campus.

We had several situations before we left on the trip—Jeff, a chaperone, had a very sick dad in Arkansas. We weren't sure whether Jeff was coming with us, or heading to Arkansas. Jeff ended up driving his truck behind us, which was a good decision because his dad passed away on Tuesday night, and he left for Arkansas Wednesday morning. The other situation happened two hours before we were to meet Saturday night to pack the van. Our dog, Tanner hurt himself and we had to make an emergency trip to the vet, possibly making the decision to euthanize him. Jacob and Drew were my heroes. Jacob met everyone and gathered all the luggage, and Drew gave me a ride when my car wouldn't start! Tanner had popped his hip out of joint, and the vet was able to get it back—we are taking it one day at a time and thankful for the time we have with him.

We had an uneventful trip to Tennessee, thank the Lord. During one of our stops on the way up, we drew names (we would do this every day) and prayed all day for the person we had drawn. Each night we would say who we prayed for, what we prayed about, and offered words of encouragement to them.

When we checked in Sunday night, we learned we would be teaming up with Sunset Hills United Presbyterian youth on a roofing and drywall project, our TeamEffort staff member would be Victoria, and we would be working on Ms. Sonia's house. The two groups hit it off right from the start and proved to be a formidable force on these projects! We got more done in our week than Victoria was hoping for, and had a great time with the other group as well. Miraculously, we had NO rain while we were doing the roof project, no one fell off or through the roof, and injuries were minor!

God showed up in several other places this week as well. At the river by Townsend, Teddy jumped into the water with his glasses on, and came up without them. A family from Texas helped dive for them, and there they were! On Thursday, we wrote prayers and scriptures on the roof and left markers for the next group to do the same. We also celebrated Ms. Sonia's birthday. We went to The Smokies to swim at The Sinks, a gorgeous setting complete with a very high rock formation to jump off of! We also enjoyed a day of rafting on the Ocoee, ate a picnic lunch at the Ocoee Olympic Park, and then swam in the river—all quite refreshing to enjoy God's creations after being on that roof!

Thursday evening, God was at work again! We picked up a rock symbolizing all the things that kept us from God—our NO's, and traded them in for a strip of cloth representing our YES's and accepting what God has done for us because we mean so much to Him.

We saw the value of building relationships with people along with hearing Pastor Saeed's witnessing while he is in prison. Some of the group's hair changed color and we said goodbye to Bob—he moved to Tennessee.

We have been changed. We've learned about helping in the community. We've grown closer to God and will show our faith in better ways and really mean it. We will strive to treat people better. Hope

Summer Breakfast Fund-Raisers

In July we continued serving full breakfasts from 8:00 to 9:00 am in the FLC. In addition to being a venue for fellowship, the breakfast's free-will offerings will be used to fund improvements in the kitchen's wiring (and along the wall between it and the FLC proper), to prevent blown circuit breakers. We have experienced a number of unintentional freezer defrosts and refrigerator power outages this month. Additional circuits will also allow a better layout of coffee makers, broilers and Crock-Pots. Debbie Moore, Kitchen Mistress, arranged for an electrician to inspect the kitchen and help us identify needed improvements. The next step is to present the desired changes to the Trustees for their approval.

A longer-range objective is to fund the purchase a modern, energy-efficient stove. This will replace the industrial one installed in 1979 when the FLC was built. This will be a big-ticket item, requiring \$5,000 or more, so it will be put on the "back burner", so to speak. Through the end of June the sanctuary offerings for the **Kitchen Improvements Fund** through July 22nd have tallied \$819.00. (Money placed in kitchen's offering plate during the breakfasts totals another \$691.00, which pays for the food and supplies used to prepare the breakfasts, and to fund the free breakfasts given to those who cannot afford them.)

Insights from Other Churches

The summer gives us an opportunity to travel and to visit other churches. We invite everyone to look for programs, hospitality, missions, furnishings, symbols or whatever that might enhance Lake Gibson UMC. On July 19th Dwight and I attended service at Monona United Methodist Church on the outskirts of Madison, WI. The following statement is published on the cover of their church bulletin every week. We thought it was a good affirmation of their Christian love for others:

"Approved by Monona United Methodist Church members

Monona United Methodist Church accepts, affirms, and celebrates the message of Jesus that God loves and accepts every person. We, as members of MUMC, are called to live and practice this message within our church congregation and our communities. We choose the concepts of acceptance over exclusion, compassion over prejudgment, and grace over bias. For these reasons we as a congregation invite all persons regardless of age, gender identity, racial or ethnic background, sexual orientation, marital status, socioeconomic status, nationality, or physical or mental ability to join us as brothers and sisters and to participate fully in the life of this congregation. Finances for the First Half of 2015

While we are better off than in many previous years, we are still behind in where we want to go this year. **June saw a significant decrease in giving.** Perhaps vacation plans caused a decrease in disposable income; but, I would hope that we all **set aside our first 10% for the Lord's work** and only then figure out what else we can do with our monies.

The first chart below reflects our church family's income, while the second reflects where we should be in any month to meet our church's financial goals. You'll note that we are approximately **10% behind where we would like to be** at the end of June. Please relook your financial situation and pray on how we might bridge this shortfall.

A Guide to Apportionments: Where Does the Money Go and How Is It Spent?

As your lay delegate to Annual Conference, I would like to share information about apportionments: what they are and how the money collected by the Florida Conference is spent. This will be the first of a continuing series of articles. I would like to start with:

CLERGY SUPPORT

Our system of appointed clergy is an essential part of our connectional United Methodist Church. The Clergy Support apportionment provides funding for the expenses borne by the Florida Conference to sustain, support, hold accountable, and nurture our clergy.

The Clergy Support apportionment provides funding for clergy salaries and benefits paid by the Florida Conference, and for other expenses related to our clergy system. Since this is the largest area of expense in the conference budget, it is also the largest single apportionment item for every local church. The conference spends nearly 100 percent of this budget each year, so, by action of Annual Conference, this apportionment must be paid in full each year by every local church. Any part of this apportionment that a church does not pay in the current year is carried forward and added to that church's apportionment the following year

The Clergy Support apportionment is used in the following ways:

Clergy Benefits and Equitable Compensation – The local church is the primary salary-paying unit for pastors, but the Florida Conference pays a variety of clergy benefits and expenses, including a substantial subsidy to ensure equitable compensation.

Clergy-Related Conference Boards – This part of the apportionment pays the meeting and program cost of our Conference Board of Ordained Ministry.

Center for Clergy Excellence – Covers the Conference Office of Ministry's staffing and expenses.

Bishop's Office and Residence – Pays the Episcopal office and Episcopal residence expenses which are not paid by the General Church through the Episcopal Fund Apportionment.

District Superintendents and Cabinet – Pays the salaries, benefits, and business expenses of our 9 district superintendents, and the meeting-related and other costs of the Cabinet.

A Guide to Apportionments: Where Does the Money Go and How Is It Spent?, Continued

Judicial Process – Pays the cost of the conference committee on Investigations and Judicial Procedures, which handles difficult clergy matters. It also pays the conference's costs related to clergy suspensions during the investigative and judicial process.

One of the additional goals for 2016 is to provide \$5,000 for each newly ordained clergy to put toward their student loans.

Lay Leaders Corner

Recently I received a letter from Wallbuilder Presentations, David Barton's ministry, which contained a commentary on the Supreme Court's recent ruling on marriage. The letter explained why the decision in *Obergefell v. Hodges* was wrong on the moral level, on the Constitutional level and on the structural level.

I believe it is important for us as Christians to have an understanding of how the Supreme Court arrived at this erroneous conclusion. This month we examine the moral level of this decision, quoting from www.wallbuilders.com website (used with permission). [Editor's note: If you want to see the references cited, please read the entire article on the website.]

On the Moral Level

"The Court's decision violates the moral standards specifically enumerated in our founding documents. The Declaration of Independence sets forth the fundamental principles and values of American government, and the Constitution provides the specifics of how government will operate within those principles. As the U.S. Supreme Court has correctly acknowledged:

"The latter [Constitution] is but the body and the letter of which the former [Declaration of Independence] is the thought and the spirit, and it is always safe to read the letter of the Constitution in the spirit of the Declaration of Independence". 1

"The Declaration first officially acknowledges a Divine Creator and then declares that America will operate under the general values set forth in "the laws of nature and of nature's God". The framers of our documents called this the Moral Law, and in the Western World it became known as the Common Law. This was directly incorporated into the American legal system while the colonies were still part of England; following independence, the Common Law was then reincorporated into the legal system of all the new states to ensure its uninterrupted operation; and under the federal Constitution, its continued use was acknowledged by means of the Seventh Amendment in the Bill of Rights. Numerous Founding Fathers and legal authorities, including the U.S. Supreme Court, affirmed that the Constitution is based on the Common Law, which incorporated God's will as expressed through "the laws of nature and of nature's God."

"These constitutional moral standards placed the definition of marriage outside the scope of government. As acknowledged in a 1913 case: "Marriage was not originated by human law. When God created Eve, she was a wife to Adam; they then and there occupied the status of husband to wife and wife to husband . . .It would be sacrilegious to apply the designation "a civil contract" to such a marriage. It is that and more – a status ordained by God. 6"

"Because marriage "was not originated by human law," then civil government had no authority to redefine it. The Supreme Court's decision on marriage repudiates the fixed moral standards established by our founding documents and specifically incorporated into the Constitution."

Next month we will examine the Constitutional level. Also get ready for the Lord's Feasts that are taking place in September.

Our mission and outreach efforts are blooming in many areas. I hear often about what our members are doing and how much they are giving in new ways. If you keep your eyes and ears open, you will hear, too. Those who are visiting and helping others do not broadcast what they are doing because they are doing it for the Lord, not for recognition.

On a recent Thursday I tagged along with Pati and Bob Gilmore and made my first visit to Hope House. I found them setting up breakfast of cereal and milk for the men who depend on this program for everyday needs. They were also busy preparing pork roast, mashed potatoes, green bean casserole and rolls for lunch. There would be ice cream, too, Pati said. Besides food, the men have a place to shower and do their laundry at Hope House. Lemonade, iced tea and coffee were also available.

They call the homeless men (and occasionally a woman) who come there "our friends". When the friends come in, they sign in. There are also sign-up sheets for use of the shower and laundry.

While there, I got to meet Lee, who lives in a tent and is from Indiana. He told me that the best thing about Hope House is having a burden lifted off his mind about what he would eat. It is a blessing to him to have kind and courteous, non-judgmental people who provide good food. I also talked to Larry, who told me that if it weren't for these folks, he would not be the man he is today. He has been homeless for 20 years. I noticed that he and others wore wooden crosses around their necks. There is always a Bible on the table.

For Christmas, Lake Gibson UMC put together large trash bags for these friends. The bags were full of gifts, Bibles and personal hygiene items. There are others from our church who also help at Hope House, including Debbie Moore, Lynn and Alan Grier and Rick and Debbie McClellan. Take a minute to talk to them about their experiences and go with them if you get a chance. They are practicing Love in Action!

Because I believe in facts and figures, I like how this book spells out what we have gained and what we haven't, what we can learn from the rest of the world, and what we can do to make a difference starting right here in Polk County.

This book is a call to arms and a must-read for anyone concerned about the number of homeless school children here in Lakeland; the increasing number of people living at and below the poverty level; and the lack of affordable, high-quality child care, paid family leave, equal pay for equal work and other social structures that have remained static over the years.

All of these things that many of us thought we would have by now, this book shows us that we are lagging behind. By following Ms. Kunin's road map we can help achieve that vision and be a part of a brighter future for our children and grandchildren.
