From the Pastor's Desk

In the past month we have witnessed several historic moments in our world, such as the reopening of the US embassy in Cuba, the staggering immigration issues in Europe and the visit of Pope Francis to Cuba and the US. The Pope is a welcome breath of fresh air that is not all about holding onto tradition or past covering up of wrong doing.

This Pope seems to be more personable, more compassionate and more realistic in the decisions he makes than those who came before him. Watching the proceedings of his visit on television, seeing the photographs and reading about the events, I am amazed at the number of people who came out to witness the Pope's visit. Perhaps the professing Christians, the church members, should once again be committed about worshipping God and filling the sanctuaries to overflowing, to show others where true hope, real compassion, and a joyful life can be found – in Christ.

## **Revised Bulletin Format Saves Money**

The Sunday bulletin format changed on September 20<sup>th</sup>. The new format allows us to get slightly more information on a single piece of paper, reducing the number of pages in each bulletin. The printing costs don't change when we increase the paper size from 8 1/2 by 11 inches (letter) to 8 1/2 by 14 inches (legal). In either case, it costs \$0.008 to print one page (one side) in black and white.

## Help Wanted

#### Your Input on Church Financial Priorities

This article expands on the financial report in September's TGN.

Each year we 'muddle through' building a proposed budget for LGUMC. But, we often find out during the year that there are additional demands for new projects. Why not build a list of projects and missions we want to accomplish, price it out, and prioritize it for inclusion in the 2016 budget?

Whether we are talking about air conditioner replacements, electrical upgrades for the kitchen, moving the food pantry so it can be expanded, offering meals in conjunction with the food pantry distributions, fabricating a crying room for the sanctuary, adding a new building with state-of-the-art classrooms, or some other endeavors, these needs should not be spur-of-the-moment thoughts, but consciously planned activities.

Every member of the congregation needs to be involved in determining the future direction of this church. Please ask God to guide your thoughts about what Lake Gibson needs to be doing to better serve Him and His people in the upcoming year and beyond. Then write your thoughts down and submit them by October 15th (before the next Finance Committee meeting on Oct 19) to the Finance Committee Chairperson (dwight@dwightkitchens.com). You can also call Dwight at 863-984-4564 or drop a note in the Finance Committee mailbox in the church office expressing your ideas and thoughts.

Each member of Lake Gibson's congregation can help us to build a **needs-based** budget. This time of the year is also the season traditionally devoted to Stewardship; that is, determining what the congregation will **pledge to tithe or donate during 2016**.

Elsewhere in this issue we are appealing to members to **increase their donations** throughout the end of 2015 to make up for significant shortfalls in the current year's budget. Donations to date have just NOT matched the expanded missions and outreach the Lord has placed in our hearts. If you are able financially to increase your usual offerings to help to make up the shortfall, please continue to contribute at the higher level in 2016.

Throughout 2015 articles in *The Good News* have asked that members who don't already do so, to start tithing to the church. Are you ready to share God's love through this action?

## Finance and Related Topics

#### **Church Finances**

If you think back to the past few years, you may remember that in 2013 we had a campaign to raise funds for carpeting in the FLC. Then, in 2014, there was another campaign to install a new sound booth and monitors in the sanctuary. For 2015, we chose to build a budget of \$321,952, which we thought properly reflected most of our needs to further the ministry of the church. This included giving the first 10% of contributions to Missions and Outreach; building a maintenance reserve for future repairs; holding two big outreach events annually; fixing an air conditioner and performing some outreach mailings, etc.

Being good stewards, we've managed our expenditures so that they don't consistently run ahead of our contributions. We held off execution of some of our plans to insure that we don't incur debt. But the trend is that donations have lagged behind the required amount for seven out of eight months.

At the end of August, we were approximately \$32,000 below the amount needed to fund our identified programs. While we have forgone some expenditures this year, we would need approximately \$40,000 per month for October, November and December to fully fund our budgeted program.

If members were to immediately **double** their contributions for the next three months, we would reach that objective. While I don't think this is reasonable to expect, I do believe we all can dig deeper. We will have to forfeit many of our identified programs without your increased financial support.

In fact, I would hope that we might collectively rethink our contribution behavior. To insure that we can continue to enhance our impact within the community in future years, we must offer more of our time, talents, prayers, and monies on a permanent basis. I pray that we can open our hearts and purses to increase what we return to our Lord in the furtherance of His ministry.

**Bottom Line**: If you are a member of Lake Gibson UMC, please tithe. Phyl and I have increased our automatic bill-pay allotment effective in October. By having our monthly tithe to LGUMC come off the top, we are paying God first. Might you do the same?

## **Food Ministry Status**

Demand for our Food Pantry have been much greater than anticipated when we built the 2015 budget. We had planned to provide 500 bags of food this year, and have already given out nearly 500 bags with 3 months still left to go. While many donate much needed non-perishable foodstuffs, the cost of perishable meats has driven our expenditures higher and higher. We've also had an increasing client demand from within our local service area. While the generous Publix donations of baked goods supplements our efforts, they do not cover the more basic nutritional requirements.

# A Guide to Apportionments: Where Does the Money Go and How Is It Spent?

#### The Episcopal Fund

This series of articles on apportionments continues with the Episcopal Fund. The Episcopal Fund was one of the three general apportioned funds which were part of the financial plan of the Methodist Church from the time of its unification in 1939. This apportionment pays for the expenses of active bishops and for the support of retired bishops and spouses. It pays for expenses related to Florida's Bishop Ken Carter.

The general church spends nearly 100% of this budget area each year, so this apportionment must be paid in full each year by every local church. Any part of this apportionment that a church does not pay in full in the current year is carried forward and added to that church's apportionment the following year.

All monies collected for the Episcopal Fund are sent to the General Council on Finance and Administration on a monthly basis. All active bishops are paid the same salary based on General Conference action each quadrennium. This fund provides the base support for the bishops of the church, not only in the US, but also for the missionary bishops around the world.

The Episcopal Fund provides salaries, moving expenses, pension, disability coverage, medical insurance and professional travel expenses for the bishops. In addition this fund helps support the cost of the Episcopal residence of our bishop as well as operating expenses for the Episcopal Office.

In 2015 this apportionment was budgeted at \$1,012,431. Lake Gibson's share was \$1,248.00. The Conference's 2016 budget for this apportionment is \$1,057,798.

Bishops have always had a very special role in our church, elected and consecrated to speak to the church and from the church. Whether presiding over the annual conference sessions, surveying disaster damage, meeting with district leaders or planting a tree, bishops accept what the apostle Paul called a "noble task". It is important that we support them with our share of the apportionment.

#### Lay Leader's Corner

Well, we made it through September and are headed into that wonderful time of year known as the fall. Before you know it, various holiday paraphernalia will be showing up in all the stores. And it's only a year away from the next national election.

I have an in-depth course on the original intent of the Constitution, recorded in Independence Hall by David Barton (of WallBuilders) and Rick Green who are Constitutional experts and advocates for the original intent of our founding documents. If you are interested in attending a 12-week study of the Constitution and the Bill of Rights to learn about executive orders, recess appointments, the Electoral College, the powers of Congress and the President, freedom of religion, and much more, please contact me at 863-816-1671 or call the church office and leave a message.

This month is the final installment of the response to the Supreme Court's decision on gay marriage by the WallBuilders organization, which is quoted from their web site. [Editor: Numbers in brackets refer to references that are contained in the full article on the <u>Wallbuilders.com</u> web site.]

#### "On the Structural Level

"The Constitution stipulates that "The United States shall guarantee to every State in this Union a republican form of government" (Article IV, Section 4). A republican form of government is one in which the people elect leaders to make public policy, with those leaders being directly accountable to the people. More than thirty States, by their republican form of government, had established a definition of marriage for their State. The Supreme Court decision directly abridges the constitutional mandate to secure to every state a republican form of government.

"To believe that the Judiciary is an independent and neutral arbiter without a political agenda is ludicrous. As Thomas Jefferson long ago observed:

"Our judges are as honest as other men and not more so. They have, with others, the same passions for party, for power, and the privilege of their corps. [11]'

"Judges definitely do have political views and personal agendas; they therefore were given no authority to make public policy. The perils from their doing were too great. As Jefferson affirmed, the judges' "power [is] the more dangerous as they are in office for life and not responsible, as the other functionaries are, to the elective control." [12] He therefore warned:

"'[T]o consider the judges as the ultimate arbiters of all constitutional questions [is] a very dangerous doctrine indeed, and one which would place us under the despotism of an oligarchy. . . . The Constitution has erected no such single tribunal. [13] The Constitution, on this hypothesis, is a mere thing of wax in the hands of the Judiciary which they may twist and shape into any form they please. [14]'

"The Supreme Court's decision is a direct assault on the republican form of government that the Constitution requires be guaranteed to every State.

#### "The Road Ahead

"The Supreme Courts decree on marriage will become a club to bludgeon the sincerely-held rights of religious conscience, especially of those in the several dozen States who, through their republican form of government, had enacted public policies that conformed to both the Moral Law and the traditional Common Law.

"While the Supreme Court decision paid lip service to the rights of religious people to disagree with its marriage decision, history shows that not only does this acknowledgment mean little but also that it will be openly disregarded and ignored, particularly at the local level. After all, there are numerous Supreme Court decisions currently on the books – including unanimous Court decisions – protecting the rights of religious expression in public, including for students. Yet such faith expressions continue to be relentlessly attacked by school and city officials at the local and city levels. (See <a href="https://www.religioushostility.org">www.religioushostility.org</a> for thousands of such recent examples.)

"Even before this decision was handed down, numerous States were already punishing dissenting people of faith, levying heavy fines on them or closing their businesses – not because those individuals attacked gay marriage but rather because they refused to personally participate in its rites. These governmental actions were initiated by complaints of homosexuals filed with civil rights commissions – and all of this was already occurring without a Supreme Court decision on which they could rely. Now that such a decision does exist, expect a tsunami of additional complaints to be filed against Christian business owners, and both the frequency and the intensity of the penalties to be increased.

"Now is the time to display stand-alone courage on the issue of marriage as well as the judicial activism of the Court – now is the time to stand up and be counted, regardless of whether anyone else stands with you. Now is the time for individuals to broadly voice support for traditional marriage (which will likely cause you to be verbally berated or attacked by its opponents) as well as for the rights of religious conscience of dissenters (which will cause you to be charged with defending bigots and haters). Good people can no longer be silent and allow themselves to be intimidated by the mean-spirited attacks that occur when you begin to speak out on this issue.

"It will soon become obvious that this decision opened a Pandora's Box that will initiate a series of policy changes affecting everything from hiring practices to college athletics, from non-profit tax-exempt status to professional licensing standards. So the battle is not over; it is literally just beginning. We have a duty to let our voice be heard.

"Strikingly, duty was the character trait of Jesus. He loved us because it was the right thing to do; He went to the cross because it was the right thing to do. It was His duty. Our Founders repeatedly praised that character trait, and noted the numerous spiritual blessings that came from its performance:

"The man who is conscientiously doing his duty will ever be protected by that Righteous and All-Powerful Being, and when he has finished his work, he will receive an ample reward. [15] Samuel Adams, signer of the declaration

'All that the best men can do is to persevere in doing their duty . . . and leave the consequences to Him who made it their duty, being neither elated by success (however great) nor discouraged by disappointment (however frequent and mortifying). [16] John Jay, original chief justice of the u. s. supreme court, author of the federalist papers

"The sum of the whole is that the blessing of God is only to be looked for by those who are not wanting in the discharge of their own duty. [17] John Witherspoon, Signer of the Declaration'

"People of faith need to regain the concept of duty, and we would do well to adopt the motto that characterized the efforts of Founding Father John Quincy Adams: "Duty is ours, results are God's." [18] Now is the time for people of faith to be silent no more."

#### A Little Bit of Heaven Child Enrichment Center

The ALBOH Child Enrichment Center has been accredited to offer Voluntary Pre-Kindergarten (VPK)! This is the culmination of a lot of hard work by the ALBOH director and staff, Pastor Steve and the Board of Directors over a year or more.

Thanks to everyone in the congregation who prayed us through this process! When the VPK is up and running Lake Gibson UMC will be able to continue to provide young children a Christian education for an additional year.

The state of Florida funds VPK for children who are 4 years old as of September 4th. A VPK class requires at least four students. This program allows children to receive a year of pre-schooling before entering Kindergarten. Among our present students, only a few would qualify for VPK.

Now the task turns to setting up the program and making sure the community is aware of it. The director has been working with regulators to get advice on doing this. The VPK program requires that each child receive 540 hours of instructional care during the year.

This means that EVERYONE in Lake Gibson UMC can take part in this initiative to show love for frail, elderly or sick church members and friends, or for those who cannot leave their residences (for example, they might be care-givers).

We have made recordings of our sermons available for visitors to take to "visitees" on MP3 players or CDs. (Shut-ins who have a computer can access the church web site and listen to the recorded scripture, sermon and YouTube copies of the worship music.) Printed copies of *The Good News* are also available to take to visitees.

Sue Shelton, Debbie Moore and Marina Garcia are working to refine the processes by which anyone who is interested can bless those in need of human contact, prayer and caring. Watch for future announcements in the Sunday bulletins and newsletters as they refine the processes.

For your convenience the Visitation Ministry calendar and cards have been moved to the narthex. They are located on a table on your right as you enter the church doors, under the bulletin board. Use the calendar to "stake out" the day(s) you plan to visit someone so we don't overwhelm them with too much love at once!

Take a card (there are multiple ones for each person on our list) which contains information about the person receiving a visit, call or card. On the back of each card, there are driving directions to the residence. There are other cards to submit after each visit or action (telephone call made, greeting or birthday card sent) to report on what you did (you know, United Methodists need to count everything). Seriously, these report cards serve a good purpose: They can be used to describe any needs you observe or learn of that someone else in the congregation may be able to meet.
