	From the Pastor's Desk	

Summer in Florida is a kick-back, lay-back time. Many of us take vacation at this time of the year, and our winter residents have returned to their native abodes. It is for those reasons that we go to one service at this time of the year, and we will suspend our reading of *The Story* for the summer. We will resume *The Story* on September 16th with chapter 19. I have heard many good comments about this study we have undertaken including: I learned this today . . .; I am seeing an overall picture of scripture; I see that God cares about me; and I now have an interest in reading the Bible. Praise God for leading us in this journey.

I hope you are beginning to see that reading Scripture does not have to be dull, and that God's word intersects with and directs the way we live our lives in this world. I pray that the things we have studied and the sermons preached have increased your desire to know more about the things of God.

Just because we are suspending the study for the summer does not mean you have to stop reading and studying Scripture. I encourage you to read any Bible translation that speaks to you. The Holy Spirit will speak to you through God's Word regardless of the translation. I personally have read many translations and each one has spoken to me. Reading other translations makes you think differently, so that you don't put God in a box; and yet with all the translations I have read, God's theme of love for mankind can be seen.

The King James Version (KJV) is the most poetic translation; the New Revised Standard Version (NRSV) is considered to be the most accurate from a scholarly view; the New International Version (NIV), used in *The Story,* is perhaps the best understood because of its common language; *The Living Bible* (TLV), which is a paraphrase, not a translation, gives a great overview and is easy to read; *The Message* (MSG), which is also a paraphrase, does the same in a more modern vernacular. The difference between a translation and a paraphrase is this: a translation takes the original scriptures and tries to translate the thought either word-for-word (or idea) into the language it is translated to. In a paraphrase, the writer takes that into account, but writes to get the point across without necessarily translating words or ideas. You need to be aware of that. Most of the seminaries and Bible scholars use the New Revised Standard Version.

While you rest, relax and have fun this summer, set aside some time for God and His Word and allow the Holy Spirit to continue to deepen your walk with God. Hebrews 4:12 says this about the Scripture: ¹² *For the word of God is alive and active*. May God's word come alive to and in you and may the Spirit activate you to draw closer to Him and His ways.

Explaining Way Forward Plans and Council of Bishops Recommendation

The Council of Bishops considered three plans developed by the Commission on a Way Forward. The Council of Bishops has indicated its majority recommendation for the One Church Plan, which could allow for different approaches in different places. Their report to the special called 2019 General Conference will also include information about the other two plans.

One Church Plan (recommended): The one-church model would allow different United Methodists in different places to make different decisions regarding ministry with or by LGBTQ persons rather than maintaining a single standard that operates everywhere throughout the worldwide church. This plan would remove restrictive language from the Book of Discipline and give conferences, churches and pastors the flexibility to "uniquely reach their missional context in relation to human sexuality without changing the connectional nature of The United Methodist Church."

United Methodists in central conferences in Africa, Asia and Europe would retain the authority to adapt the Book of Discipline and could continue to include their traditional language and values.

This plan would also protect the rights of United Methodists whose theological convictions will not allow them to perform same-sex weddings or ordain LGBTQ people.

Traditionalist Plan: This plan would affirm the current language about homosexuality in the Book of Discipline and seek to strengthen enforcement for violations of church law.

Connectional-Conference Plan: This plan would create three connectional conferences based on theology or perspective, each having clearly defined values (accountability, contextualization and justice). The three connectional conferences would function throughout the worldwide church and the five existing U.S. jurisdictions would be abolished.

Adaptations to the Book of Discipline would be allowed by each connectional conference. Annual conferences would determine their affiliation with a connectional conference. Local churches who choose a branch other than the one chosen by their annual conference could vote to join another conference. This plan would require multiple amendments to the denomination's constitution.

The full report and legislation will be available following translation into the official languages of the General Conference. The estimated release date is July 8.

The 2019 General Conference will receive the report and legislation and make decisions about whether or how to change our current connectional relationships.

Ruling

The purpose of the special General Conference 2019 stated in the Bishop's call is limited to receiving and acting upon a report from the Council of Bishops based on the recommendations of the Commission on a Way Forward. Petitions to the special General Conference 2019 may be filed by any organization, clergy member and lay member of the United Methodist Church as long as the business proposed to be

transacted in such petition is in harmony with the purpose stated in the call. It is the obligation of the General Conference to determine, in the first instance, through its committees, officers and presiders, acting in accordance with *The Discipline* and the rules and procedures of the General Conference, whether any such petition is "in harmony." However, business not in harmony with the purpose as stated in the call is not permitted unless the General Conference by a two-thirds vote shall determine that other business may be transacted. Judicial Council Decision 1360 and The Way Forward

My response, today and on behalf of the United Methodist Council of Bishops, to Judicial Council Decision 1360: The statement expresses gratitude for the Judicial Council's work and our continuing commitment to serve and lead our church. I have added an additional word about purpose.

Gratitude

We want to thank the Judicial Council for their service to the church through the affirmation of two key principles—the specific nature of the call for the special session, to receive and act on the report of the Council of Bishops based upon the work of the Commission on a Way Forward; and the General Conference's authority to decide on what is in harmony with the call.

Service

Our motivation in making the request for the Declaratory Decision is in recognition of the historic nature of the Special Session of the General Conference in 2019, the need for focus on the stated purpose during these three days, and to create an orderly environment without distraction and chaos, so that the delegates can do their best work.

Leadership

I am grateful for Bishop Bruce Ough, who spoke on behalf of the Council's petition for a Declaratory Decision. This was an appropriate exercise of service to the church (*Book of Discipline*, 414, 415), as we have responded to the request for leadership from the 2016 General Conference. We will continue to serve our beloved denomination under the guidance of the decision and in consultation with the Commission on the General Conference.

Purpose

The motivation of the bishops in seeking clarity about what will be before the 2019 Special Session has always been grounded in the desire to create "an orderly environment without distraction and chaos so that the delegates can do their best work." In this regard, our work, which is very much the appropriate responsibility given to us by the church, has been mischaracterized by some in the media. We hope to avoid a scenario where there are many hundreds or even thousands of petitions that come before the delegations, with only three days to process them. Allowing petitions from all simply requires the church to manage the process with as much efficiency, patience and grace as possible. All of this is for a greater purpose: to find a way forward for The United Methodist Church, so that God can continue to use us in making disciples of Jesus Christ for the transformation of the world.

The above figures reflect that we are not over-obligating the church, and not spending more than we have in our accounts. But, we are not raising funds at the rate we had discussed for our three new designated accounts: 1) roof replacement, 2) air conditioning replacement, and 3) setting aside money for an insurance reserve fund to cover a catastrophic act of nature.

Earlier, we asked each of the 134 member families if they would contribute approximately \$5 per week per adult to each of the above designated funds. Roof replacement would take two years, air conditioner replacement would take three years, and our insurance reserve would take five years before we had raised sufficient funds. At this point, eleven weeks after our initial announcement in mid-January, we would have hoped for contributions similar to the following (136 families times 15 weeks times \$5 per account):

^{*}\$13,902 of this amount was carried over from the end of December 2017, meaning that we have actually contributed \$3,464 of new funds during 2018 for air conditioner replacements.

Unless we increase our contributions in the future, we will have to delay execution of these projects much further into the future. Merely designating funds for these purposes without increasing total contributions serves no purpose. We all need to increase the total amount we give to insure that both our general operating costs are met now and our future projects are completed on time.

The next Finance Committee meeting is scheduled for Monday, June 18th, at 7:00 pm in the FLC.
