No doubt you have heard the news reports about the United Methodist Church splitting into two or more different organizations. This can only occur if the 2020 General Conference, which will be held in Minneapolis, Minnesota from May 5-15, approves the proposal. The General Conference may adopt it as it stands or amend it, or even reject it.

Regardless of that it has become apparent there are several divergent theologies within the UMC and different interpretations of scripture. I asked Staff/Pastor-Parish Relations Committee (S/PPRC) to just think about some of the "Big Questions" that may be coming that we will have to answer; this was before the separation proposal was presented and I remind you as I did them: this is not my church or your church – it is God's church.

At the last S/PPRC meeting it was suggested that the congregation be made aware of these questions also. I am listing them here and asking that you be in prayer about them. No decision has been made on any of them, and I and the leadership of LGUMC desire your prayerful, honest feedback concerning these questions. Regardless of where you may stand in these issues, I respect your decision, love you as a brother or sister in Christ and offer God's ministry and grace to you. I look forward to hearing your thoughts.

The Big Questions:

- 1. If the UMC formally splits, where will we land? How many ways may it split? How long will a formal separation take to implement?
 - 2. If the UMC officially takes a conservative traditional position, will we stay with it?
 - 3. If the UMC officially takes a progressive position, will we stay?
- 4. Can our congregation, LGUMC, survive a congregational vote on human sexuality? We know there are many opinions concerning this issue within our own membership.
 - 5. Should a vote be avoided because of the animosity it will cause?
 - 6. What would need to be done to get this congregation ready for such a vote or action?
- 7. If there is a clear exit procedure, do we want to leave the UMC? Can we afford the terms? If there is an exit, where do we go progressive or traditional or something else?
 - 8. If there is no resolution to the conflict at GC 2020 do we stay United Methodist?

Please let me and/or a member of the LGUMC Leadership team know your thoughts.

The following information is taken from Mr. Klassen's web site:

"Eduard Klassen is a Paraguayan folk harpist and speaker, now living in Canada, who has presented over 4500 music concerts in 40 countries since making a personal commitment to Christ. A typical concert presentation by The Klassens includes a variety of Christian harp music from South America, North America and Europe, interspersed with personal testimony and stories of God's work in his life, from boyhood in the wilderness of Paraguay to the present. Eduard's natural sense of humor helps him to develop an excellent rapport with audiences wherever he goes."

"Christine Klassen was born and raised in Ontario, Canada, and has played the piano since 1976. She studied nursing in Stratford and graduated as a Registered Nurse. Christine has recently started to perform once again in concerts with her husband Eduard."

Tithes and Charity

The word charity originated in late Old English to mean a "Christian love of one's fellows." You've often heard the phrase "Charity begins at home." What you generally don't hear is "Charity does not end there."

Many denominations hold that Jesus taught that "tithing must be done in conjunction with a deep concern for justice, mercy and faithfulness." Being a Jew, Jesus understood Continued . . .

the tithe to be the common practice of *ma'aser kesafim* (tithing 10% of their income to charity).

Some Christian Churches, such as those in the Methodist tradition, teach the concept of Storehouse Tithing, which emphasizes that tithes must be prioritized and given to the local church, before offerings can be made to apostolates (an association of persons dedicated to the propagation of a religion or a doctrine) or charities.

The Book of Discipline of the United Methodist Church states that it is the responsibility of ecclesiastics (ministers) to "educate the local church that tithing is the minimum goal of giving in The United Methodist Church."

Why is this important? We recognize that there are many pulls on our financial resources. But, we often reverse-prioritize our contributions, preferring to fund "Designated Contributions" prior to "General Contributions." This means that we donate to "charity" first and "tithe" second.

In the Methodist tradition, Storehouse Tithing permits our church to operate and offer services to the community. This should be our **first priority**. Our "charity", often reflected in designated contributions, should be a secondary priority. This is not necessarily a "zero-sum game". To do one does not require that the other suffer. Rather than slight one when funding another, we collectively should look at how our discretionary purchases affect our ability to honor God.

If you noticed the financial news this past holiday, Americans spent record sums. We chose to make purchases. Were they all long-lasting, or something which quickly faded? Possibly we should revisit our priorities and put our funds where they will do the most good, within our tithing and charities.

Update of Key Holders

For a number of years, we have been collecting **designated funds to replace air conditioning units** on our campus. Last year, we replaced one major unit within the FLC and two smaller units in FLC classrooms 1 and 2.

This past month we replaced two air conditioners which have been sorely missed from within our FLC's kitchen. Thankfully, A Little Bit of Heaven replaced air conditioning units within their building using their own earnings.

Why outright replacement rather than repair? Well, the law has banned the former refrigerant. New units use a different refrigerant which is less toxic to the environment (and to us). Also, new units are more energy efficient, which should reduce our electric bill.

While we are making progress on replacing our old units, we have a long way to go. We still have **another eighteen units** which will eventually require replacement. They may not all fail this year, but they will ultimately need to be replaced.

Your contributions through offering envelopes designating funds specifically for "Air Conditioner Replacement" permits us to make these upgrades to our physical plant. Thank you for your contribution. We all enjoy the comfort of conditioned air!

Announcements and other information may be found in the newly installed, clear plastic holder in the narthex. As you enter the narthex, the holder is on the left-hand wall. Take home whatever interests you. Printed copies of the newsletter will also be located in this holder.

Our newsletter, *The Good News (TGN)*, is a great way to find many details about what is happening in our church, conference, district and community. Being printed monthly, based on a submission deadline about one week before the first Sunday of the upcoming month, the *TGN*'s calendar may not be up-to-date with the latest changes or added events.

Of course, if event sponsors or participants don't provide articles to the editor about their events (or ideas, concerns, etc.), the newsletter won't contain that information. **Everyone is invited to write articles for** *TGN*.

Alternatively, our **website** has the ability to keep us abreast through a **quickly updated calendar** (found at www.LakeGibsonUMC.com under the "Our Calendar" selection in the red banner heading).

Our calendar is kept up-to-date by the Administrative Secretary and should always reflect the current scheduling. Last year online donations from the Lakeland walk raised \$3,000. The 2019 donations totaled \$6,750, and \$703,865 has been raised in the last 35 walks.

CROP Hunger Walk is a project of *Church World Service*, which keeps three-fourths of the money raised to fund regional and overseas projects including providing food, water, housing, education and training, disaster and refugee assistance. One-fourth of the money raised here stays in Lakeland to support Talbot House and Light House Ministries.

Church World Service was founded in 1946 and is a cooperative ministry of 37 Christian denominations and communions, providing sustainable self-help, development, disaster relief, and refugee assistance around the world. The CWS mission is to eradicate hunger and poverty and to promote peace and justice at the national and international level through collaboration with partners abroad and in the US. Let's Start a Youth Sewing Class!

We tried to get a fiber arts group going this past fall, but there was little interest at that time in starting a mixed group (knitting, crocheting, quilting and sewing). As you know, the church has several older girls in Kidtricity; some of them (or their parents) have expressed interest in having the girls learn how to sew.

Here's a chance for inter-generational mentoring: ladies of a certain age (i.e., most of us) teaching boys and girls the basics of sewing starting at ages 10 or 11. We propose to use borrowed sewing machines and probably limit the students to no more than 4 for the first group while we figure out the best way to do this.

Ann Kneeland has volunteered to lend up to four sewing machines and supplies for our students. She proposed that classes initially be conducted on Wednesday nights during choir practice (6:30 to about 8:00 pm), perhaps in the office conference room since the FLC classrooms are in use.

Different days, times and locations could be arranged to suit the needs of mentors and students. Phyllis Kitchens has also volunteered to help out. Ideally, we would like to have one adult to each student.

To ensure the highest quality care, we have partnered with PTSD experts at the Children's Hospital of Philadelphia and Nemours/ Alfred I. duPont Hospital for Children to create valuable web-based information and tools designed for each member of the family's unique experience.
