## From the Pastor

The big religious holidays and celebrations are behind us with Pentecost Sunday on May 23rd. The next major Christian Church celebration is All Saints Day in November. According to the church calendar the time between Pentecost and All Saints Day is called Ordinary Time and its color is green. This means that if we were a liturgical church, the parament bookmarks and altar coverings would be green.

I understand the church year calendar and its significance, yet I think we do a great injustice to ourselves and God to call any time ordinary. It is during our ordinary routines that God often breaks into our lives to challenge and transform us. It was during Saul's ordinary life chasing followers of The Way that Jesus appeared to him on the Damascus Road, and changed this Jesus-denier into perhaps the greatest example of faith the world has ever seen.

It is during ordinary times that the roots of faith are nourished and grow deep. It is ordinary Bible study and worship times that strengthen our faith, comfort our fears and calm our anxieties. It is ordinary events that allow us to develop and deepen relationships with other Christians and to witness to unbelievers. Maybe the color green is for the growth God causes during these ordinary times.

While times may look ordinary, there are extraordinary things going on behind the scenes. Great people of faith are shaped, tempered and honed during ordinary times so they can be ready to lead effectively when times are critical. Character is developed in ordinary times when few if any people are watching. God shaped King David in the fields as he shepherded his family's flocks. God developed Moses over a period of 40 years on the back side of a desert. God is molding you and me in the ordinary times of our lives.

When I look back over life I cannot really say anything God does is ordinary. God has a way of doing something special with very little. God has a way of taking a nobody and making them an instrument of His grace. God goes into the alleyways and back streets of a city, into the no-name towns and crossroads of the world to call, equip, empower and mold His people to share His love with all the world.

There is nothing ordinary about a child of God or the time God takes in loving his children. Maybe we should start looking at every day as a special day – a day when suddenly God may break into our lives and miracles will happen. Enjoy the miracle of today.

## A Message from Bishop Carter

Today it was announced that I will begin to serve as bishop of two annual conferences, Florida and Western North Carolina, as of September 1, 2021. This was the recommendation of the Southeastern Jurisdiction Committee on Episcopacy, the SEJ College of Bishops, and the Council of Bishops.

I will begin my tenth year in Florida this fall. I have been blessed by you and sense there is important ministry before us: supporting vital local churches, dismantling racism, clergy health and resilience, and proclaiming the message of the continuing United Methodist Church as our way of sharing the grace of Jesus Christ with the people of our communities and beyond.

I will begin serving the Western North Carolina Conference. This is my home conference, one that supported and confirmed my calling to the work of a bishop. At the same time, I have been away from the conference for nine years, and so I will enter into a time of deep and active listening to and sharing with leaders across the conference in the fall.

To serve both annual conferences, Florida and Western North Carolina, will require a model of shared leadership, flexibility and residence in both areas. I thank Jennifer Davis, Kim Ingram, Molly McEntire and Alex Shanks, who serve on the SEJ Committee on Episcopacy. I thank you all for your faith in me and for our partnership in the gospel (Philippians 1:5). I will give myself wholly to this work, and I ask for your prayers; indeed, I depend on them. I am excited about the future and claim the promise: "God is able to accomplish abundantly far more than all we can ask or imagine" (Ephesians 3:20).

## Opinion: Who's Church Is It Anyway?

As you know, the General Conference of the United Methodist Church has been postponed over the past two years due primarily to COVID-19. Between August 29th and September 6th 2022, a number of proposals will be discussed regarding the future of our denomination. The United Methodist denomination will likely continue, but there may also be offshoots with slightly varying theology.

Over the past year, we've worked hard to upgrade our church's ability to minister in new ways. You've seen necessary changes which permitted us to worship remotely until we could join together again. These helped address our short-term needs to minister to our flock. We hope many of you have made a transition back to in-person attendance at worship. But, for those who are homebound, or have preexisting conditions that increase the risk from COVID-19, our snowbirds, our hospitalized, and others, we will continue to offer livestreaming of services, classes and gatherings as a means of reaching out and sharing with other Christians.

As we gather together, another question arises. Do we have an obligation to maintain our campus irrespective of who owns the physical plant? Currently, the individual Methodist Conferences own church properties within their jurisdiction. Individual churches maintain the properties. A primary discussion to take place in 2022 is whether churches separating from the United Methodist family get to keep their physical property and financial assets.

For this reorganization to be amicable, I believe each church congregation will make their own decision and join the denomination most suited to their values and beliefs. If you voted along with the congregation's majority, you should be happy. If you voted with the congregation's minority, you will probably be disappointed. This will likely result in some members departing our congregation and others migrating into our congregation based on their theological bent.

Now, what if the General Conference makes no decision the next time it is held? We delay longer in resolving some underlying issues. But, this also means that our physical plant continues to deteriorate if we take no actions to maintain it. Some in Lake Gibson UMC have voiced the opinion that we should not make any improvements or repairs to our campus until we know what options the General Conference has accepted.

I vehemently disagree. This is God's house no matter which interpretation of theology is preached. I have an option to move to another church at any time, but while here, my obligation is to support this congregation and its physical plant.

COVID-19 showed us how our sanctuary's heating and air conditioning system is outdated. Repairing it now would be a wise thing to accomplish during 2021. Shortly we are going to need new roofs on both A Little Bit of Heaven Child Enrichment Center and the church office. We should be planning now on how these needs can be addressed. They should not be pushed into the future based on some hypothetical outcome of a future General Conference.

Should we get new members after the General Conference, they will benefit from our forethought. Should some of our members move elsewhere, they should benefit from the prior actions of their new church's trustees in maintaining their plant. In all cases, no matter whose name is on the deed, our properties belong to God. We are merely the trustees and should meet our obligations to make our physical plant a safe, environmentally sustainable and inviting location for worship.

## New Podcast Focuses on Anti-Racism as Christian Discipleship

"Expanding the Table," a new video podcast series from the United Methodist General Commission on Religion and Race, will debut on **Tuesday**, **June 1**, **2021**. Series guests will focus on how individual Christians and church-based entities can and should engage the work of creating racial justice and ensuring anti-racism.

Guests for the **first podcast - titled "Racism, Police Reform and Faith" -** are the Rev. Kirk Lyons of Brooklyn, NY, and the Rev. Jeremy Wicks of Traverse City, Michigan. Both United Methodist pastors are leading community-wide conversations and demonstrations that call attention to implicit and explicit racial bias experienced by Black and Brown people at the hands of police officers. Both are bringing together church, community, and law-enforcement members to seek solutions.

The Commission's interim General Secretary, M. Garlinda Burton, says the new podcast series will offer a deeper understanding of how racism harms both the church and society at large and how antiracism and racial justice function as an expression of Christian discipleship.

"Expanding the Table' explains how people of faith can foster and practice anti-racism from the lens of followers of Christ. Religious and civic leaders will share practices and experiences that will inform and inspire Christians to live out their faith and bring the Word of God to bear on championing human and civil rights for all people," Burton added.

As a White man, Wicks, a former police chaplain and reserve officer, says that he came to embrace movements like Black Lives Matter after he "actually started listening to Black people in my community and witnessing how they were treated." Wicks said the murder of George Floyd led him and members of his mostly White United Methodist congregation to "open our eyes to the racism that was happening and work together for racial justice through police reform."

Since 2008, Lyons has led men's nighttime prayer walks through some of the most crime-ridden communities in New York, praying with and for gang members and drug dealers. As they established connections with the mostly Black and Brown men from the streets, Lyons said the churchmen began to hear stories, not just about how known criminals are treated, but how Black and Brown residents in general encountered and experienced the police.

"Too many police officers bring an indifference and fear of people of color to the job, to the point that they don't see us as human," Lyons said. He and his group are now in conversations with law enforcement on the value of community policing and having residents and police officers build relationships and trust with one another.

Lyons and Wicks will talk about their work as an outgrowth of their understanding of the Gospel of Jesus Christ and offer ideas for how Christian communities may learn more and get involved in local police reform and anti-racism efforts.

Shortly after they retired a year ago their van was slammed between trucks on I-75, leaving Jim with a horrible spinal cord injury at his 4th cervical vertebra (C4). Since then he has developed life-threatening infections from pressure sores. Karen sent this request to people who have asked to stay in touch:

"Jim has a custom manual wheelchair. We needs to get him the best cushion for his needs. He is unable to shift his weight at all. He is healing from serious pressure wounds and will always be at great risk for them. It is crucial that he has the proper cushion, but clinicians tend to recommend the ones they've always known about, and company reps recommend the ones they sell.

"We really want to hear from people who sit in wheelchairs every day. They are the only real experts. If you know of someone who can give us feedback on their experience, please ask them to contact us.

"Please reply with a brief recommendation based on your own [or a family member's or close acquaintance's] experience with cushions answering the following 3 questions:

- 1. What brand and model cushion do you use?
- 2. What do you like about the cushion?
- 3. Has your cushion choice improved your life and helped you avoid pressure wounds?"

## Florida Sales-Tax-Free Holidays Coming Soon

#### Disaster-Preparedness - May 28 - June 6, 2021

The "Disaster-Preparedness" tax holiday will run from May 28 through June 6 and is expected to save shoppers \$10.5 million in state and local sales taxes. Its timing is tied to the June 1 start of hurricane season.

During the period, shoppers will be able to avoid paying sales taxes on such things as reusable ice packs that cost \$20 or less; portable radios, gas tanks and packages or batteries that cost \$50 or less; non-electric food coolers that cost \$60 or less; tarps that cost \$100 or less; and portable generators that cost \$1,000 or less.

#### Freedom Week - July 1 - July 7, 2021

State economists projected that the "Freedom Week" tax holiday, which will start July 1, will save \$54.7 million for shoppers. During that week, people will be able to avoid paying sales taxes on tickets purchased for such things as live music, athletic contests, in-theater movies, cultural events and entrance to museums and state parks. Tickets could be purchased during the week for events that occur later in the year, including annual passes.

The holiday will also provide sales-tax exemptions for such outdoor equipment as tents, grills, bicycles, kayaks and fishing gear.

#### Back-to-School - July 31 - August 9, 2021

The "Back-to-School" Tax Holiday is from July 31st to August 9th. Over these 10 days, Floridians will pay no sales tax for certain clothing of \$60 or less per item, school supplies of \$15 or less per item, and the first \$1,000 of personal computers and related accessories.

This sales tax holiday adds to your blessing as you purchase needed back-to-school supplies for the children at the Florida United Methodist Children's Home or at Padgett Elementary School, just down the street from church.

The ladies worked hard setting up the food line and filling bags. It was a long day! On May11th Tom Burns met Dan and Ann Johnson, Bev Henrich and Cindy Webb at the FLC to load our vehicles to take the food bags to Bartow. Tom also took home all of the empty boxes to recycle.

There were five transitional students waiting for us in Bartow to unload our vehicles. These students were excited to see so much food being delivered for the project. ## Are You Ready to Unmask?

Many of us would welcome the ability to remove masks during worship. The COVID-19 pandemic has given us an opportunity to reflect on how blessed we have been within our church family. A few have tested positive for the infection, yet only endured mild symptoms. Praise God that we have been spared compared with some other congregations around the nation.

Yes, soon we may be able to completely discard the wearing of masks inside our church. But, should COVID-19 rebound locally, we are relying primarily on the ability of inoculations to prevent the spread. There is another tool available to increase safety which has not been seriously considered.

In looking towards the future, is it time to finally 'bite the bullet' and look at improving the capability of our air conditioning system? Current systems are generally more energy efficient, permit the inclusion of fresh air from outside, and have improved high efficiency particulate air (HEPA) filters. HEPA filters and the incorporation of fresh air would have helped us better deal with the COVID-19 pandemic. We have been saving into a designated fund for over four years to make the air conditioning upgrade a reality.

The Trustees have recently asked for an estimate of the funds required to enhance our sanctuary's air handling system. Our first estimate is approximately \$36,000 for an enlarged system with fresh air intakes on the two larger (7.5 tons) of four new units, ionizer/air purifier on all four units, and smoke detectors required by county codes.

Our designated Air Conditioner Reserve currently has \$18,335 in the account. This leaves us with **\$16,827 still required** to make this upgrade a reality. (There may be some additional funds which could be expended against this project.) How much longer will we need to wait before this upgrade is completed?

If 34 families pledged \$500 each towards this project, we could get additional quotes, choose the best installer, and have an improved sanctuary in the next few months. This upgrade saves energy, improves the quality of life

for people with breathing difficulties and puts a state-of-art mechanical system in our sanctuary. Are you ready to help us reach this goal?

#### **Justice is Love Out Loud**

What does the Lord require of you but to do justice and to love kindness, and walk humbly with your God?

As we explore how to engage missionally in our communities, there is a resource in three of the counties that our District covers. These are the **faith-based community organizations** of the DART network: **PEACE in Polk County**, HOPE in Hillsborough County and FAST in Pinellas County.

Polk Ecumenical Action Council for Empowerment (PEACE) is a congregation-based community organization whose purpose is to build justice ministries, train members from diverse congregations to work together to identify root causes of community problems, and to take action to resolve them. The purpose of the organization is to build a strong coalition capable of negotiating the interests of our community with a special concern for the vulnerable.

These organizations teach leaders in congregations how to advocate for justice on issues right where they live: **transportation**, **mental health**, **and diverting youth from incarceration for minor**, **non-violent offenses**. The benefit to churches is helping their leaders learn the art of engaging in the public discourse on critical issues that affect their neighbors.

PEACE currently includes 23 congregations that represent over 20,000 Polk County residents who are ethnically, religiously, and geographically diverse. We are united by our common desire to make Polk County a better place to live, work, and do business. ## **Thanks for Your Support during the Pandemic**

Life has been vastly different during the Coronavirus pandemic of 2020-2021. Fortunately, Lake Gibson United Methodist Church has fared rather well overall. Only four people within our congregation became infected early on, and thankfully, they had mild reactions. We're not aware of any congregational hospitalizations due directly to the pandemic.

We quickly moved to livestreaming our services and offering Bible studies through Zoom meetings. Of course, we initially closed our in-person services before we were able to start remote worship. In attempting to follow the directions of both the Centers for Disease Control and the Florida Conference, you saw some drastic changes within the church when you did return. We discontinued our normal monthly committee meetings early on and held discussions with committee chairpersons when decisions had to be made.

Other than social distancing, hand sanitization, and masks, you saw many of changes. Most of the pews were removed to insure we kept appropriate separations. The pastor was forced to remain more stationary so that cameras could consistently keep him in focus. Singing was limited to prevent the spread of virus droplets. We all made necessary, but unwelcome, changes to the way we worshiped.

We also made major changes which you may not have noticed. Most of the sanctuary stage wiring was redone. Floor boxes were installed to prevent tripping on wires running across the floor. Peripheral lighting was changed from fluorescent to light emitting diode (LED). Point-Tilt-Zoom (PTZ) cameras were added. Chairs replaced most of our pews which permit us to rearrange the seating plan as social distancing guidelines evolve and more people get their COVID vaccinations. Microphones, sound board, computers, and other electronics were upgraded. The Family Life Center (FLC) classrooms 1 and 2 also got an upgrade with a PTZ camera and combination speaker/microphones to support a Sunday school class and future committee meetings.

As you are, I hope, aware, we took advantage of the Payroll Protection Program during 2020 to help cover a portion of our salaries (\$25,500 grant). This was a significant boon to our bottom line. But, we also spent funds to protect our members and upgrade equipment for livestreaming. Techsoup, a group which supplies us with discounted software and hardware, also gave us a \$2,000 grant which was used for three of our computer purchases.

With all this in mind, we thought it was time to provide an update on the expenses involved:

## Creating a Life Story for Someone Living with Dementia

Capturing someone's life through a Life Story is a fun and meaningful activity. Creating the Life Story of someone living with dementia can be both satisfying and therapeutic for the individual and the family. The story includes special events, important people in their life and promotes and supports mental stimulation.

There is no right or wrong way to write a Life Story but if you need ideas, you can find templates to use on the internet. Writing the story is extremely helpful to provide to new caregivers. Whether your family member is planning a short overnight respite in a memory care program, attending a day program, or new caregivers are working with your family member in the home, having an easy to read Life Story can quickly provide information that will help engage the individual in meaningful conversations about the past where memories are clearer and more vivid.

Other ideas/uses of a Life Story:

- •A quick reference of likes and dislikes and needs of the person.
- •Celebrate life achievements and remarkable events, people, and pets in the individual's life.
- •A wonderful book that a grandchild can read with the grandparent and connect on a more personal and relaxing level.
- •Provides comfort and can be used to distract the individual from stress and anxiety.
- •Taking the Life Story to new places can help the individual adjust to unfamiliar surroundings.
- •Include pictures and names of people, but avoid asking "do you remember them?" Just recall events or funny stories that would be enjoyable.
- •The Life Story can become a legacy of family relationships and personal history.
- •Have the individual "autograph" the book as the author.
- •Collect information at different times and avoid bombarding the individual with too many questions. Don't be afraid to be creative. Add drawings, poems, birthday cards, or anything that will bring moments of shared joy.

This book can be a wonderful gift to present to a son, daughter or grandchild once the individual is no longer living.

Families will find that creating Life Stories is an enriching experience. The story can also be an audio recording with the individual telling personal stories. Reach out to family members and friends for memories or ideas. This person-centered approach on storytelling lends itself to providing individualized care and creates comfort and pleasure for the individual, family member, or caregiver.

Connections, a respite and recreation program in our memory ministry, supports individuals and their families living with memory challenges. Connections provides opportunities for self-expression by connecting friends, family and faith. Although we are not able to meet at the church due to the health and safety concerns due to the COVID-19 pandemic, we have created a Connections Zoom group on Monday mornings and are able to share music, prayer, poetry, and wonderful adventures.
