From the Pastor

Thank You, Lord! Thank you that we made it to 2022. After back-to-back years of a pandemic, unprecedented natural disasters, political discord and all the other problems we have experienced in the previous two years, I am sure we are all looking forward in hopeful expectation of a better year in 2022. Will it be better or will the virus mutate again? Will inflation spiral out of control? Will jobs rebound? Will the supply chain be reconnected?

Only God knows the answers to these questions, but I remind you He and He alone is in control. On Christmas Eve we read these words from the Gospel of John, chapter 1, verse 5: ⁵ The light shines in the darkness, and the darkness did not overcome it. Jesus Christ is the light that came into a dark world and the darkness could not overcome it.

We definitely live in a dark world and many of us feel the darkness is winning. Yet there are bursts of light occurring in many places. In the midst of the storms people from around the world are sending aid. It is not common knowledge but behind the scenes in the Middle East the Christian church is growing at exponential rates.

In our own church while the pandemic limited our numbers attending worship in-person, we are reaching twice the people we did before with the Live-Casts and recorded services. Because of the economy we are seeing more and more people needing assistance, and we have been able to meet that need – thanks to you and your generosity. During this dark time, we have been able to upgrade our air-handling system, adapt the sanctuary to meet the new requirements of spacing and cameras, and put a roof on the office. Perhaps we are looking at the circumstances that surround us in the wrong way.

A flashlight or lantern is not needed in the daylight, but when it is dark that same source of light is valuable. When everything is going well and there is no need, we often forget about God, but when things are bleak and dark, we look for his light. Perhaps we should look at the days that we are living in as great opportunities for the church to do what it is supposed to do – give light and hope to the world through Jesus Christ.

What if this New Year we began not looking for a better year, but for a brighter light to shine in our world for Jesus? The same darkness John spoke of in his Gospel is in the world today, and in that darkness Jesus Christ still shines. We as the church and as followers of Jesus were instructed by Jesus with these words: ¹⁶ "In the same way, let your light shine before others, so that they may see your good works and give glory to your Father in heaven". Matthew 5:16 (NRSV).

Also remember as Mordecai told Esther: "You were born for such a time as this." So, let your light shine brightly for the glory of God!!!

Becoming a caregiver for someone living with memory loss can bring fear, sadness, feelings of being overwhelmed, anger, and even helplessness. It is shocking and confusing when your family member's behaviors change. and you are unprepared to manage the mood swings, or even the depression your family member may experience. Until you can begin to **understand** what's causing the changes, you just don't know what you can do about it.

Finding answers, support and connecting with others who understand and can relate to what you're are going through will be the first step in building your toolbox and tackling this new challenge. That is why our **Memory Ministry is offering a Virtual Caregivers Support Group** on Tuesday evenings, 7:00 to 8:00 pm via Zoom. Research shows that support groups are effective in reducing caregiver burden, and gaining a sense of empowerment, control or hope.

The First UMC Virtual Support Group for Caregivers will offer opportunities for caregivers to:

- feel less lonely or isolated.
- reduce distress, depression, anxiety or fatigue
- talk openly and honestly about your feelings
- learning strategies and skills to cope with the challenges
- bring together people who are going through or have gone through similar experiences.

As we did last year, we are **NOT ACCEPTING LARGE PIECES OF FURNITURE** due to limited demand for them, lack of space to store large items, and unwillingness of other charities to accept these unsold items.

Commentary on December Article by Martin Thielen by Maria Thomas

My heart was broken as I read Martin Thielen's article [*The Toxic Evangelical Variant*, November 1, 2021, from his Doubter's Parish blog] in last month's newsletter. He starts off by saying what a blessing the evangelical Church was to him. There here he was loved and he found family. There he was educated. There he was introduced to the God of the universe and found meaningful service and a way to express his love for Jesus through his vocation. Still he felt the need to move to a more "progressive" form of Christianity.

In one big way he is correct. Many parts of "The Church" failed the people when it came to slavery in the Civil War era and Jim Crow laws as late as the 1960's as well as many opportunities the Lord gave us in between. The critical race issues of today could have been avoided if only we had stood up to that discrimination. I admire my Quaker brothers and sisters who responded to this issue much faster and better than most did.

However, Mr. Thielen's assertion that we who disagree with him on certain points are 'toxic" is as misinformed as anyone who calls himself a Christian can get. What he really wants at best is to ignore certain teachings in the Bible, and at worst to call it a hate book. He says we are toxic because we are angry "all the time". Enraged over things like abortion, transgender bathrooms, Critical Race Theory (CRT) and vaccine mandates, etc." He is quite right. Many of us are righteously angry over the killing of the unborn! I love what Dr. Ben Carson said regarding babies in the womb. He said "I have done in utero surgery on a baby in the womb and I can assure you it is alive!" We also are angry about transgender bathrooms that open the door to all kinds of pedophiles!

CRT wants to demean a whole race of children from kindergarten thru college. I don't think Jesus would approve of that either. And vaccines that use aborted baby parts to either to test them or as an actual part of the vaccine cannot be taken by those of us whose consciences say not to. I believe Mr. Thielen is the one who is in the wrong because he wants us all of us to agree with him on these issues or be considered toxic.

We are equally toxic if we don't believe in evolution (a fact, not a theory, to him [Thielen]), or if we don't believe in climate change or (once again) the COVID vaccines. He says we oppress women and require "submission to their husbands." I honestly don't think he truly understands what submission really means, OR the powerful role women play in all areas of society. Without demeaning the amazing role women play in the workforce, I agree fundamentally with the statement that "the hand that rocks the cradle rules the world." Women are the most influential creatures on earth! Consider Susanna Wesley!

He says we hurt the LBGTQ community. I hate it when I hear an ill-informed Christian tell a gay person that they are an abomination to God. Because, guess what? So were you before you repented Continued on the next page . . .

and turned your life over to Jesus! God does not hate LGBTQ people. He loves them enough to want to win their hearts and tell them the truth. He is all about transformation. I know that's true because I see it in the Bible and have experienced it for myself. If you know me now and also knew me before Jesus came into my life, you would know what a miracle looks like! Jesus loves us enough to tell us the truth. EVERYONE has issues and needs God to deal with them.

My son has a Doctorate in Psychology from Regent University. One young lady in his cohort was admittedly gay. BUT, she chose not to act on her feelings because she saw clearly in the Bible that acting on her feelings would be sinful. At the same time, she was looking to God to transform her physical desires as He had her spiritual desires. But whether He did or not, she was going to remain true to His Word. Often after healing someone Jesus would tell them to "go and sin no more." Those are my goals, too: to stay true to the Word of God, even if someone thinks I'm toxic, and to stop intentionally sinning when God has corrected me. How does one explain away Romans chapter 1, the book of Jude, and the teaching of the entire Old Testament beginning with God "created them male and female?"

Then we come to the definition of Evangelical. Answers given by those asked really make one wonder just WHO was being asked [in Mr. Thielen's article] to define the word. Evangelical means *messenger* (evangel in Greek) who shares the Good News. An Evangelical Church is one that shares the Good News of Jesus sent by God to pay the penalty for sin and provide a way back to Him. I'm pretty sure that the Church that did so much for Mr. Thielen in the beginning of his spiritual journey told him that.

We get into serious spiritual trouble when we start trying to make God or His Word conform to our particular way of thinking. I absolutely agree that Jesus was all about love, kindness, mercy, inclusion, grace, compassion and justice. He was also about Truth. Jesus told Pilate that the reason He came, the reason He was sent into the world, was to tell us the Truth. Jesus is Truth and the Word of God is our plumb line. Without it there would only be "your truth" and "my truth." Truth leads to transformation. It's the "truth that sets your free." God's truth. Not your truth or my truth. Proverbs 14:12 says "There is a way that seems right to a man, but its end is the way of death."

Thielen then suggests we leave Churches that teach these life-giving truths, and find a progressive one that sees the Word of God as flexible. One that keeps up with the culture. I would say to him culture changes, but God's Word has stood the test of time. God Himself is the same yesterday, today and forever. Good religion will always hold out the Word of Truth with love and compassion. Jesus holds the Word of life out to you, Mr. Thielen. In Revelation 2, in speaking to the Church in Ephesus, He says in Revelation 2:2-5 *"I know your deeds, your hard work and your perseverance . . . you have persevered and endured hardships for my Name and have not grown weary. Yet this I hold against you: you have forsaken your first love. Remember the height from which you have fallen and do the things you did at first." Look into your heart Mr. Thielen and come home to the real Jesus who loves us too much to leave us as we are.*





Settlement in Boy Scouts Pending Bankruptcy

United Methodist leaders have reached a settlement in the matter of the Boy Scouts of America's (BSA) pending bankruptcy proceedings. Upon final court approval, the settlement would resolve any claims of sexual abuse that may have occurred in congregation-sponsored Scouting programs.

Under the terms of the settlement, United Methodists would raise and give \$30 million over a threeyear period into a fund that will be utilized to compensate survivors, and United Methodist congregations that charter Scout troops and packs would be released from all abuse claims involving Scouting activities. A team has been formed to identify strategies and materials that may be used to raise the funds. The church would also agree to work for the healing of survivors and recommit to work toward ending sexual abuse of young people. Through the General Commission on United Methodist Men, United Methodists will work with the BSA to continue to ensure Scout safety and grow Scouting ministry as part of its mandate through *The Book of Discipline*.

"We are sorry for what occurred and are praying for all those who experienced harm through Scouting activities. We are committed to the protection of children and youth, and the United Methodist Council of Bishops will be working with the church, the Survivor Working Group and BSA to address policies, programs, and procedures in order to keep Scouts safe from abuse," said Bishop John Schol, chair of the UMC leadership team created to support the United Methodist chartering organizations in the bankruptcy matter.

The settlement follows months of mediation by an Ad Hoc committee of bishops, chancellors and general agency employees that has been advocating for United Methodist interests.

"I want to thank everyone who has been working through the mediation process for the healing and just resolution of the survivors," said Schol. "Our settlement agreement has the support of both the BSA and the Coalition of Abused Scouts for Justice."

The United Methodist Church has long worked proactively to prevent child abuse. The percentage of claims in the last 20 years potentially related to United Methodist congregations-sponsored scouting units is less than 1 percent of all UMC claims.

Under the terms of the agreement, denomination leaders will intensify efforts to prevent and raise awareness of child sexual abuse.

The Council of Bishops of The United Methodist Church has committed to lead the church in carrying out the following:

• Work with all United Methodists to raise funds for the Survivor Trust Fund.

• Tell the story of harm done to survivors through a series of articles to be published by the denomination and by each U.S. annual conference to draw attention to child sexual abuse and call upon the church to be vigilant in working to prevent child sexual abuse in churches, homes and the community.

• Carry out a denomination-wide review of all Safe Sanctuaries and other policies to safeguard young people from sexual abuse and update policies as necessary and ensure the policies are being followed.

• Provide opportunities for sexual abuse survivors to share their experiences with United Methodist leadership if they choose to do so.

• Work with all United Methodist ministries and with the Boy Scouts of America to continue to make programs safe for all young people.

• Provide leadership to help all BSA chartering organizations to make a \$100 million contribution to the Survivor Trust Fund. [Editor: This action applies to the UMC and all other chartering organizations.] Participate as a member of the Survivors Working Group

The Ad Hoc Committee recommends that churches who filed a proof of claim vote "yes" on the plan and for those who previously voted "no," the Ad Hoc Committee recommends congregations change their vote to "yes." An email from conference leadership will be sent to churches that filed a proof of claim on how to vote "yes" and how to change a vote from "no" to "yes."

Bike Hope Love began in 1987 as a small group of Methodist cyclists called **Pedaling Parsons** that shared a passion for cycling, community and helping their vulnerable neighbors.

"They had the idea that instead of just riding for fun and fitness, they could ride with a purpose. The vision of that founding group resulted in a decades-long movement that has pedaled over 18,000 miles and has raised over \$900,000 for mission projects in the United States and around the world.

Today these former "Pedaling Parsons" aren't just clergy, but are made up of both pastors and laypeople. Some ride bikes and others are part of the support team that keeps the riders on the road, gets them to their destinations, refreshes and feeds them on the tour and helps them when they break down, get lost, or get hurt.

Bike Hope Love riders are husband and wife, father and son, father and daughter, mother and son teams; they are retirees; they are youth; and they range in age from 9 to 83. This community of cyclists don't mind riding in the rain or sleeping on church floors. They love God, meeting new friends, and the adventure for the sake of serving God and others."
