## From the Pastor on Easter 2022

I have been thinking a lot about what I could say this Easter. As my retirement approaches, faster than I would like, – the official date is July 1, 2022 – I ask myself this question, "What message do I want to convey to the church?" This may be the last Easter sermon I ever preach; again, what do I say? So, today I write a personal note to you about "Why the empty tomb matters!"

There are many people who doubt that Jesus rose bodily from the grave. I had seminary professors with PhDs who said once you are dead you are dead, no resurrection. I know of UMC preachers that deny the physical resurrection of Jesus as well as the virgin birth and the deity of Jesus. They say Jesus was a regular person like you and me. He was a good person we should seek to follow, but he was not deity. To each of these I say you are not, and should not be, a preacher of Christian faith. To deny any of those foundational tenets of Christianity is to deny who Christ is according to our faith practices and our Scriptures.

The fact that the tomb was found empty, along with the witness of the two angels who ask, "Why do you seek the living among the dead?" (Luke 24) should prove to us that Jesus is the Son of God and has the power of life and death as well as the keys to hell. If this miracle is true I can take the rest of Scripture as being true also. That Jesus is God's Son (proving his deity), I can trust the virgin birth (Jesus fully human yet fully divine) and I trust the promise he will return one day. If the resurrection is a fact I can now face suffering and death with the hope, no the assurance, that there is more to life than what happens on this earth to this physical body. I will see my Christian loved ones again in eternity. Believing in the resurrection of Jesus is the foundational tenet of Christian faith. As Paul says, "If there is no resurrection we are to be most pitied" (1 Cor 15:19). I ask you, if there is no resurrection, why should I serve God? If there is no resurrection how do I know I have eternal life? If there is no resurrection why do I believe there is a supreme God?

The message I leave you is this: Trust God and trust the Scriptures. Hold fast to the faith you have been taught by the Mother Church of tradition. Listen respectfully to those with differing opinions, but put your faith in God and His Word (both Scripture and Jesus). Do not let anyone, a preacher, a District Superintendent or a Bishop, tell you anything contrary to scripture. They did not rise from the dead – ONLY JESUS HAS, and it is to Him we owe our primary allegiance and loyalty. He is the one every knee shall bow before and every tongue confess He is Lord. I do so now and trust you will to.

Happy Easter and may you have a Glorious Resurrection Sunday!

#### **2021 Food Pantry Impact**

The number of Food Pantry guests in the first half of 2021 was about the same as in past years, but "business" kicked up surprisingly from August to year-end. We don't know what drove the increase in people asking for help, but thanks to the Lord and your faithful donations, Lake Gibson UMC was able to meet the needs. In total we gave out **617** bags of groceries and **610** bags of Publix baked goods. These numbers represent opportunities to help members of our community.

For **2022** the average weekly number of bags of groceries ranges from 20 - 23, with monthly totals between 80 and 92 a month. This is more in line with the years before 2021.

Thanks to everyone who supports the Food Pantry. This is a partial list of tasks and team members:

Friendly and caring people who interact with our guests as they hand out bags,

Night owls who pick up bakery donations from the Lake Gibson Publix on Wednesday and Saturday nights, and black out the prices on each item,

And to the Food Pantry coordinator, Ann Johnson.

# A Letter from the Bishop about the Vision of the Continuing United Methodist Church

Dear Friends.



I write to you as we lament the violence and loss of life in the Ukraine. We pray for peace, and we lift up United Methodist churches in this area and all people living in harm's way.

Each day we learn more about the implications of the postponed General Conference. I am a part of the work of the Council of Bishops in this season, and am I writing to provide guidance to you and your local churches.

I regret the activity of closed meetings being held in United Methodist churches in Florida by the Global Methodist Church. I do not understand the need for closed meetings. I do not understand the turning away of persons at the door of a church. I do not condone falsehoods being shared about The United Methodist Church. I rely on the spirit of 1 Peter 3:15 and appeal to us to take the high road and "give an account for the hope that is in us."

We are United Methodist disciples of Jesus Christ. We are a people under the cross of Jesus Christ, and the flame is the warmth of the Holy Spirit that calls us into connection with each other. We are an evangelical church that lives deeply in the grace of God and therefore shares this grace with all people, without exception.

A series of district gatherings are being planned for later this month. Superintendents will host these opportunities for you to <u>learn about the vision of the continuing United Methodist Church</u> – a vision that preserves the rich heritage of Florida United Methodism while committing to an ever more faithful and inclusive church for all. We want to encourage you in the important ministry you are doing in your local context. These meetings will be open to all. Two webinars will be held [were held] to give insight and support to our clergy and lay leaders as they guide us through opportunities and challenges of this season. The webinar for laity will be [was] held on Sunday, March 20 at 7:00 pm. The webinar for clergy will be [was] held on Monday, March 28 at 1:00 pm. Registration links will be sent out next week. #### **United Methodist Women is Now United Women in Faith!**

Press Release, March 2, 2022

United Methodist Women is now United Women in Faith! The move is part of a refreshing of the organization that includes a new logo and an array of new and improved programs to nurture current members and welcome new women to join to put their love in action on behalf of women, children, and youth.

The organization announced the new operating name in the March - April edition of **response**, its bimonthly magazine for members, and is launching the rebrand with a new website and Facebook event March 3 at 1:00 pm ET. The new programs are fruits of research conducted over the past five years with more than 24,000 United Methodists and women of other Christian traditions participating in the surveys, focus groups and interviews. This input informed the prayerful discernment of staff and elected leaders.

The changes are designed to address the different needs and life stages of current members and new women and expand options for membership and engagement. The new name also aims to welcome current members whose local churches may choose to disaffiliate from The United Methodist Church as well as women of other faith traditions who want to join.

New and innovative programs will be rolled out throughout 2022, including:

- A new, easier to navigate website with a homepage designed to pique new women's interest in United Women in Faith and a special portal set to come online later this year where members can log in to access additional resources.
- A new "All-Access" National Membership Option enabling women to join United Women in Faith via the new website and participate online or in person at local units or larger events.
- Soul Care Retreats, a pilot recruitment program for members and their nonmember friends and new women focused on nurturing women's bodies, minds, and spirits.
- Innovations to Mission u, the organization's longtime spiritual growth and transformative education program. Beginning in spring 2022, Mission u will introduce new curricula each year—one for children, one for youth and one for adults—all focused on a shared biblical theme. The new Mission u curricula will be more adaptable for use in small groups, local churches, vacation Bible schools, retreats, and other settings. Through these vibrant, relevant, justice-oriented, and biblically centered curricula, Mission u will continue its commitment to learning together for the transformation of the world and expand its impact.
  - More targeted giving options and new interactive online resources for members.

"This is an exciting time for our organization!" said Harriett Jane Olson, CEO of United Women in Faith. "Looking back, we see the through lines for our organization—faith in God, love for each other and commitment to putting our faith into action supporting women, children, and youth. These commitments have been expressed in different ways at different times using different names, always calling women to world changing action. This combination of a new look, more accessible resources for members and new ways to participate, positions us for impact in our own journeys and in how we engage the world that God so loves."

'Ainise 'Isama'u, United Women in Faith board president, said the changes express the organization's core values in ways that will excite current members and invite new women to join us. "I'm confident our members will be excited about these changes," she said. "Together we are creating more opportunities for engagement with more women through new programs and updates of long-standing programs that embody our core values. Things change. People change. But God remains, and that continues to be the purpose behind everything that we do in this organization."



While rarely discussed, look at information under the Financial button. On the left-hand side of the page is detailed information regarding Planned Gifts. You may have received information on how to give a bequest to an alma mater, a favorite charity, or numerous other groups. These are groups which, through advertising, attempt to pull at your heartstrings. Can making disciples of Jesus Christ be any less worthy?

My father and step-mother took the time to establish a trust for their children. With their passing, our family has been informed that the trust will be distributed this year. We plan to tithe a portion directly to our church. This also brings to mind that we have not rewritten our wills in over thirty years. It is time to clarify how our current physical property and financial investments will be distributed. Whether our assets are distributed piece-meal over time, or through a will at our passing, this is something which we should consider now.

If you have not looked at your will, trust, or bequest, do so. NOW IS THE TIME. They can always be amended and updated before they need to be used. Don't be like those who say they will but fail to do so. You can contribute in making future disciples of Jesus Christ.

# Global Methodist Church Sets Official Launch Date May 1, 2022

**March 3, 2022** – With humility, hope and joy, a 17-member body of theologically conservative Methodist clergy and laity, known as the Transitional Leadership Council, is pleased to announce the Global Methodist Church will officially launch on May 1, 2022.

Supported by fervent prayers, faithful discernment, and a sure hope for the future, the Global Methodist Church is a Holy Spirit inspired movement committed to making disciples of Jesus Christ who worship passionately, love extravagantly, and witness boldly.

Thousands of Methodist clergy and laity from around the world have worked together for over three years to lay the groundwork for a new, theologically conservative Methodist denomination steeped in the great ecumenical and evangelical confessions of the Christian faith. They envision a church fired by a warm hearted, Wesleyan expression of that faith that is dedicated to sharing the Good News of Jesus Christ in word and deed.

"The Global Methodist Church will warmly welcome people eager to join others in fulfilling its mission," said the Rev. Keith Boyette, Chairman of the Transitional Leadership Council and President of the Wesleyan Covenant Association. "We have heard the truth of Jesus Christ, experienced the forgiveness of his grace and love, and so bear witness to his transforming power. We long to take our place alongside brothers and sisters in the church universal who seek to live out their faith every day so that others might come to know Jesus Christ as their Lord and Savior."

After having worked for years to renew and reform The United Methodist Church, in late 2019, theological conservatives faithfully joined leading UM Church bishops, and leaders of centrist and progressive advocacy groups to hammer out an amicable and orderly plan to divide the UM denomination.

That plan, known as the *Protocol of Reconciliation and Grace through Separation*, rapidly gained the support of people across the UM connection, and it appeared headed for approval at the denomination's May 2020 General Conference. Unfortunately, after two previous postponements, the UM Church's Commission on General Conference announced today that it is postponing the conference for a third time. Its inability to find ways to help international delegates gain access to COVID-19 vaccinations and secure U.S. entry visas led to the cancellation.

Consequently, the *Protocol* cannot be adopted this year, so faithful and patient United Methodists will not be afforded the opportunity to part ways with the UM Church according to the *Protocol*'s terms. Under its provisions, every theologically conservative local church and annual conference would be allowed to join the Global Methodist Church with clear title to all of their property and assets in perpetuity.

"Many United Methodists have grown impatient with a denomination clearly struggling to function effectively at the general church level," said Boyette. "Theologically conservative local churches and annual conferences want to be free of divisive and destructive debates, and to have the freedom to move forward together. We are confident many existing congregations will join the new Global Methodist Church in waves over the next few years, and new church plants will sprout up as faithful members exit the UM Church and coalesce into new congregations."

It is anticipated that some theologically conservative local churches will find annual conferences willing to negotiate fair and just exit provisions, while others will unfortunately face obstacles placed in their paths. The Transitional Leadership Council decided it was time to launch the Global Methodist Church, so those who can leave early will have a place to land, to begin building and growing, and making room for others to join later.

### Global Methodist Church Sets Official Launch Date, Continued

Boyette said, "For theologically conservative local churches deciding to remain in the UM Church for a time, we are confident Good News, the Confessing Movement, UMAction, and the Wesleyan Covenant Association will continue to vociferously advocate for the ultimate passage of the *Protocol*. Every theologically conservative local congregation and annual conference should have the right to join the Global Methodist Church with all of their property and assets intact."

Over the past two years the Transitional Leadership Council has met on almost a weekly basis to create a Global Methodist Church *in formation*. Informed by the work of the Wesleyan Covenant Association's Global Council, Legislative Assembly, and dozens of task force teams that prepared white papers covering a host of issues, the members prepared a *Transitional Book of Doctrines and Discipline*. The book will govern the church during a transitional period prior to a convening General Conference to be held in the next 12 to 18 months. The *Transitional Book of Doctrines and Discipline* and much of the Transitional Leadership Council's work can be found on the new church's website and in *Crossroads*, the weekly e-newsletter it publishes. Persons and churches interested in aligning with the Global Methodist Church may express their interest through the new church's website.

"As we embark on this great venture, we know we will stumble and fall at times," said Boyette. "But with the great prophet Isaiah, we also firmly believe we will, in God's good time, 'run and not be weary,' and 'walk [in the way of the Lord] and not faint!""

## **Debate about Church Future Heats Up**

[Some of the information in this article has evolved since it was written in late January 2022; however, a member of the congregation asked that it be published because there are many conversations about the UMC's future flying around. Due to the lateness of its receipt, the length of the article and the number of pages already in the issue, I didn't put it in the February newsletter, and then I forgot about it when preparing the March newsletter. Editor]

Two years after a diverse group of United Methodists introduced a proposal for separation, a global pandemic continues to keep the denomination uneasily together. However, with General Conference scheduled for later this year, preparations are accelerating for the future United Methodist Church and the theologically conservative group that plans to break away. Meanwhile, a theologically progressive group that announced the launch of a new denomination in 2020 is re-evaluating its plans.

Amid all these preparations, long-simmering disputes over LGBTQ inclusion — that led to the proposed split in the first place — have started boiling up again. Council of Bishops President Cynthia Fierro Harvey acknowledged that anxiety is running high for many in the church. She said she often reminds herself of Paul's advice in <a href="Philippians 4:6-7">Philippians 4:6-7</a> not to be anxious but to bring prayers and petitions to God. "We need to navigate this season with love and care for one another and not heap more harm on one another and The United Methodist Church," she said.

It's been a busy season. Recent developments include:

- The bishops sharing their vision for the continuing United Methodist Church.
- The North Central Jurisdiction approving a covenant for the future that welcomes and affirms LGBTQ people, and that covenant facing a challenge under church law.
- lowa Conference leaders facing a backlash after opening the way for same-sex weddings.
- The East Zimbabwe Conference removing its lay leader because of his involvement with an advocacy group.
- Both theological conservatives and progressives making plans for their futures.

Tensions reached a breaking point with the 2019 special General Conference, which, <u>by a vote of 438-384</u>, strengthened bans on same-sex weddings and "self-avowed practicing" gay clergy. The relatively narrow vote did not settle the debate, but <u>instead sparked widespread resistance</u> and hastened discussions of a denominational divorce. But for the past two years, much of the denomination has been in a holding pattern waiting for action by General Conference — now twice postponed by the pandemic.

The coming legislative assembly faces multiple proposals for division along theological lines. The most endorsed of these is the Protocol of Reconciliation & Grace Through Separation, negotiated by a professional mediator with a theologically diverse group of United Methodists. Under the proposal, churches and conferences that support restrictions on gay marriage and ordination can vote to leave with church property and \$25 million to form a new traditionalist denomination. The protocol also sets aside \$2 million for any other new Methodist denominations that form.

The Wesleyan Covenant Association, a theologically conservative advocacy group, has worked toward forming that traditionalist denomination — <u>now named the Global Methodist Church</u>. However, General Conference delegates have the final say on whether the protocol takes effect as written.

The Commission on the General Conference, which organizes the international assembly, expects to decide by the end of March whether the big meeting can go forward as scheduled <u>Aug. 29–Sept. 6 in Minneapolis</u>. The commission is looking at not just delegates' access to vaccines but also the availability of visas. While visas are an issue for every General Conference, the pandemic has caused more difficulties. The commission has been clear that this coming assembly must have a reasonable level of global participation. [The General Conference of the UMC has been postponed to 2024. Editor].

The commission met January 26, mostly in closed session, and did not announce any final decisions about whether General Conference can go forward. Even with General Conference still up in the air, United Methodists are moving ahead with plans to go in different directions.

In November, the Council of Bishops offered <u>a vision for the continuing United Methodist Church</u> as a big-tent denomination that is rooted in Scripture, centered in Christ and welcoming to all churchgoers — whatever their sexual orientation or theological outlook. "Our best witness is to love each other as Christ loves us, to show the world the supernatural power of the Holy Spirit to bind us together despite our differences," the bishops wrote in "A Narrative for the Continuing United Methodist Church."

Harvey, who also leads the Louisiana Conference, said she sees United Methodist congregations, conferences, agencies and individual followers of Jesus who are already living into the narrative. "By that I mean, they are being faithful to God's call to create space and embrace people from the left, the right and the in between," she said.

As the bishops were developing their narrative, an ad hoc group of United Methodists urged bishops not to wait for General Conference but allow congregations that want to do so to leave with property now. The group's open letter, titled "A Call to Grace," garnered more than 2,030 signatures.

<u>The special online session of the North Central Jurisdiction</u> — representing 10 conferences in the U.S. Midwest — offered a statement that shares similarities with both the bishops' narrative and "A Call to Grace." By a vote of 135-32, the delegates approved a <u>"Covenant to Build BeLoved Community"</u> that calls on the jurisdiction to work to end racism and to create a culture that welcomes and affirms LGBTQIA+ people. The covenant also encourages conferences to accommodate local congregations and clergy seeking disaffiliation.

John Lomperis, a delegate from the Indiana Conference and advocate with the conservative Institute on Religion and Democracy, asked for a decision of law on whether the covenant violates the Book of Discipline. Lomperis specifically questioned the section that requests bishops "dismiss charges related to LGBTQIA+ identity or officiating same gender weddings." That section goes on to say, "We will not restrict God's calling based solely on a candidate's sexual orientation or gender identity."

Bishop David Bard, who was presiding when Lomperis asked for a ruling, <u>decided that the section</u> <u>is aspirational and therefore does not violate church law</u>. The section "asserts important values and encourages consideration of how one might live into those values," wrote Bard, who leads the Michigan and Minnesota conferences. All bishops' rulings of law must go for review by the Judicial Council, the denomination's top court, <u>which recently has begun deliberations on its fall docket</u>.

Invoking both the bishops' narrative and the North Central Jurisdiction's covenant, Iowa Conference Bishop Laurie Haller <u>announced that the conference would not wait to live out the documents' vision</u>. While no one would be compelled to violate their convictions, the conference vision statement said, the question of same-sex weddings would be up to local congregations starting this month.

"To put it clearly, pastors will be able to choose which weddings they officiate, as long as it is two consenting adults who have been counseled," the statement said. "Likewise, church leadership, in consultation with their pastors, will be able to determine their own policy regarding weddings."

Many bishops have quietly held complaints related to homosexuality in abeyance as requested by the protocol. Both the Wesleyan Covenant Association and Good News, another theologically conservative advocacy group, argued that Haller's statement went further and violated church law. "If Bishop Haller and her cabinet permit this policy countenancing defiance of the Discipline to go into effect, I think they risk returning the UM Church to the level of conflict witnessed at the 2019 General Conference," warned the Rev. Keith Boyette, WCA president.

In his Perspective column for Good News, the Rev. Thomas Lambrecht wrote that the announcement could have significant consequences. "Local churches and laity have power, too," he wrote. "They have the power of purse strings. ... And secular courts might be inclined to say that, by this action, the lowa conference has repudiated its status as a United Methodist conference, breaking the trust clause that holds churches hostage to the whims of a wayward church leadership. Who knows where this road of rule by power could lead?"

Members of the lowa extended cabinet told UM News that the cabinet took the lead in developing the conference's vision statement in response to false rumors and fears being spread about the future United Methodist Church. "In this statement by the cabinet, we have been clear — and this is our truth — that for anyone who wants a future in The United Methodist Church, they will have a home," said the Rev. Lanette L. Plambeck, assistant to the bishop and director of clergy and leadership excellence. Living that vision right now, Plambeck said, gives United Methodists the chance to make decisions based on facts, not fear. "There is a difference between a truth that is asserted and a truth that is observed and experienced," she said.

lowa is not the only conference seeing changes. At a virtual session December 4th, the Zimbabwe East Conference resolved to relieve Simon Mafunda as its conference lay leader following the WCA hiring him as its Africa coordinator. Delegates from the seven districts unanimously passed a vote of no confidence, asserting that his new employment presented a potential conflict of interest with his voluntary conference position as lay leader. Mafunda called the vote flawed, saying it did not follow any established procedure. Continued on the next page . . .

"It is very key to be careful how we follow procedures so that it validates the outcome of the results," Mafunda said. "I still respect and appreciate those who elected me to office, but feel that they were all cowed down by this process." He added that he does not see a conflict of interest. "My appointment as a consultant had nothing to do with my role as a conference lay leader," he said. The conference has not yet named a new lay leader.

Amid these disputes, the WCA continues its planning for the Global Methodist Church. In December, the WCA Sexual Holiness, Wholeness, and Brokenness Task Force released <u>a 22-page report</u> on proposed teachings around sexuality and gender. WCA members are now taking feedback and plan to bring the report for adoption at its Global Legislative Assembly on May 7. The WCA continues to prepare other documents on sacraments and other aspects of church life for the still-being-formed <u>Global Methodist Church</u>.

The WCA also announced plans to pay for General Conference delegates in Africa, Europe and the Philippines to travel to receive vaccines with the intention of ensuring General Conference goes forward. However, bishops, General Conference organizers and others <u>criticized the move for helping only delegates from the central conferences and not the community at large</u>.

Meanwhile, the people forming the <u>Liberation Methodist Connexion</u> (LMX) offered a transparent look at the challenges faced by all groups trying to start something new. In 2020, <u>the connexion announced its launch as a new denomination</u> that would center the voices of people of color as well as queer and transgender individuals. In late 2021, the connexion's collaborators offered <u>a full assessment of where they are now</u>, noting unexpected challenges and limited resources. "Common ground was easier to find when we were focused on critiquing old institutions," the group said in the statement. "It has been much harder to find as we all bring ideas about what can be."

For now, the connexion — which is all unpaid volunteers — has decided that: "Positioning ourselves against the United Methodist Church or any other spiritual institution does not serve us and is an unfair burden to place on ourselves." The connexion also no longer is identifying itself as a denomination. "We are a group of people working to dismantle existing systems of oppression and liberating marginalized people, and we want to do that with as many people as possible," said Adrian Hill, one of the connexion's collaborators and a General Conference delegate. "These issues transcend membership in existing denominations."

## **Changes Coming to Thursday Night's Zooming the Peace**

While we have hearing assistance devices available in the sanctuary for Sunday services, we have not previously found a good way to help the hearing impaired for our Zoom meetings.

We've recently found a way to add closed captions to the Pastor's Left Overs. We hope that this will make it easier for those who might be slightly hearing impaired to enjoy Zooming the Peace discussion of the weekly Left Overs (videos that are posted on Facebook and our website each Wednesday).

We're still trying to figure out how Zooming the Peace oral discussions might be closed captioned. Trying to type into a chat what someone is saying is currently beyond our skill level. If anyone has an idea for an affordable way to convert speech to text in real time on Zoom, please let us know.

With some work we might be able to figure out how to add closed captions to our sermons, although this will take more research to figure out. Separating the recorded sermon from everything before and after it currently is very laborious. We'll also need a volunteer for that job.

#### The Boy Scout Oath Makes a Difference When You Live the Words

"On my honor, I will do my best to do my duty to God and my country and to obey the Scout Law; to help other people at all times; to keep myself physically strong, mentally awake, and morally straight."

For more than a century, Scouts all over the United States repeated that oath. Those are strong words to live by, speaking of faith, service, self-care, and high morals. And despite the much-publicized scandal that rocked the Boy Scouts of America, those higher goals remain.

"Leadership development and servant development are important values that Scouts can learn. Scouting does lift up one's duty to God and country," Rev. Dr. Sharon Austin said. "It enhances your faith and shows what it means to be a good citizen." Dr. Austin, the Director of Connectional and Justice Ministries for the Florida Conference of the United Methodist Church, has first-hand knowledge about the impact of Scouting. Her father was an Eagle Scout. Her husband received a citation for starting a troop of Scouts with Down Syndrome, all of whom were adults. The couple's son was a Scout, and their daughters, along with Dr. Austin, were Girl Scouts.

The United Methodist Church has a lengthy history with Scouting. Many churches throughout Florida chartered Scout troops, allowing them to meet on church campuses. Some congregations recently celebrated Boy Scout Sunday, where Scouts participated in the services.

#### **Boy Scouts, Continued**

The Florida Conference Scouting Coordinator, Randy Nunley, has served as a volunteer for the Boy Scouts of America for the last 16 years. He was a Den Leader when his oldest son joined the Cub Scouts in the first grade. For two years, he was a Cubmaster, then became an Assistant Scoutmaster when his son moved on to the Scouts BSA Troop.

In addition to various leadership roles, he serves as the Troop Chaplain for a Scouts BSA Troop at a UMC in the Central Florida Council of BSA, and has received the BSA's District Award of Merit and the Silver Beaver Award. "The Boy Scouts of America provide the connections, programs, and opportunities for youth to apply the practical lessons of character," he said.

TRUSTWORTHY. Tell the truth and keep promises. People can depend on you.

**LOYAL.** Show that you care about your family, friends, Scout leaders, school, and country.

**HELPFUL.** Volunteer to help others without expecting a reward.

**FRIENDLY.** Be a friend to everyone, even people who are very different from you.

**COURTEOUS.** Be polite to everyone and always use good manners.

**KIND.** Treat others as you want to be treated. Never harm or kill any living thing without good reason.

**OBEDIENT.** Follow the rules of your family, school, and pack. Obey the laws of your community and country.

**CHEERFUL.** Look for the bright side of life. Cheerfully do tasks that come your way. Try to help others be happy.

**THRIFTY.** Work to pay your own way. Try not to be wasteful. Use time, food, supplies, and natural re sources wisely.

**BRAVE.** Face difficult situations even when you feel afraid. Do what you think is right despite what others might be doing or saying.

**CLEAN.** Keep your body and mind fit. Help keep your home and community clean.

**REVERENT.** Be reverent toward God. Be faithful in your religious duties. Respect the beliefs of others.

In response to FFPSA, last fall FUMCH began a Family Foster Care program that allows a foster parent couple to live in a cottage on the Enterprise campus. Five cottages are planned to be remodeled into foster family homes. This change should allow children from the same family to stay together and live with one couple of foster parents. Under the previous residential model, two sets of cottage parents rotated on and off duty for two-week periods.

## **Nurturing the Spirit of Persons Living with Memory Loss**

Spiritual and social connectedness are key to our overall well-being. This is especially true for persons living with memory loss. Creating and sharing joyful moments that promote spiritual and social growth can improve their overall happiness and quality of life. Not only does nurturing their spirit affirm their personhood, but it also brings opportunities to maintain relationships with their care partner, friends, and family.

Despite their confusion and difficulty retrieving memories, persons living with memory loss retain the ability to feel and respond to emotions. They may have trouble expressing their spiritual needs, but finding ways to help them sense and feel God's love will bring meaning and purpose to their lives.

Making a prayer box together can bring spiritual awareness. Find a small box for you and your family member to write down prayers or Bible verses on slips of paper. You can also decorate the box together. Bring out the box when you sense their need for comfort. Rituals such as lighting a candle while you share the prayer box can bring a familiar closeness to God.

Many people find a connectedness to God in nature. Taking walks, being outdoors, smelling the flowers, hearing the birds sing, and watching the sunset and sunrise will bring opportunities to appreciate the beauty of nature that can feed and nurture the physical soul.

#### **Avoiding Accidents in the Home**

Taking measures to improve safety can prevent injuries and help a person with memory loss or dementia and the caregiver feel more relaxed and less overwhelmed. Changes in the brain and body can affect safety. Areas affected can include physical abilities (difficulties with balance and changes in gait), judgment (forgetting they turned on the stove), and challenges with time and place (getting lost in the neighborhood). Also, be mindful of changes in vision, depth perception, hearing, and sensitivity to temperature. Below are other suggestions to consider:

- · Take a walk through and around the outside of the home and evaluate safety risks.
- · Avoid serving food and beverages that are too hot.
- · Install walk-in showers and add grab bars to the shower or tub and at the edge of the vanity to allow for independent and safe movement.
  - · Add textured stickers to slippery surfaces.
  - · Apply adhesives to keep throw rugs and carpeting in place, or remove rugs completely.
  - Monitor the hot water temperature.
- · Keep hallways and entrances well lighted. Keeping lights on in the evening as the sun goes down can minimize confusion from seeing shadows in the early evenings.
- · Remove guns from the home and keep them safely locked up. Also, make sure knives, power tools, and dangerous machinery are out of sight.
  - · Make sure chemicals are in a safe place.
  - · Check your home for lighters or matches that could be problematic.
  - · Be prepared with emergency phone numbers and make sure they are easily accessible.

Paying attention to home safety can help the individual maintain his or her independence longer, minimize stress, and aid in the ease of caregiving.
