Pastor's Thoughts

As I write this note the fall season is beginning; the nights are actually two degrees cooler. But, along with the change of seasons comes one of the busiest times of the church year.

During the month of October we will hold our Charge Conference at First UMC in Lakeland. There your Administrative Council will elect officers for the new year and complete reports for 2023.

Also, our congregation will begin its Stewardship program for 2024 in October. You will be reminded that a church doesn't exist to raise funds. It exists to do ministry, which is to be supported by the people of the congregation. How you support that work is between each of you and God. Stewardship is based upon you and your relationship with God. Our Consecration Sunday will be November 12, followed by a celebration dinner in the FLC.

We will be observing World Communion Sunday on the first Sunday in October. Laity Sunday will be observed at worship on the 15th of October. And, we will again have a Sunday of Song on the last Sunday of October. On the 1st Sunday of November we will observe All Saint's Sunday.

Plans are already in the works for Advent and Christmas. Our choir will present us with a Christmas Cantata on December 17. We will observe Christmas Eve with an early service on the evening of the 24th.

Of course, you should know by now that our congregation has voted to disaffiliate from the UM Church. That action should be completed by December 15th. You will be hearing much more about what comes next and choices we will be making in the near future.

Ten Principles of Tithing:

- Tithing shows that we acknowledge God's authority over our lives and finances.
- Tithing reveals that we provide that God is our Provider. It is from him all blessing flow, and to him we return a tenth.
- Giving to God what is his already opens the door to God's returning immense blessings to us. It is an amazing thing that God rewards us for doing our duty.
- Today, when people tithe to the local church (the New Covenant version of the Old Covenant "storehouse"), it enables called servants of God to serve without encumbrance in their service to the Lord.
- Local churches are able to help the poor and those facing unexpected hardships by using the tithe in conjunction with other special offerings.
- The tithe is outside the jurisdiction of the Law and is actually built into the framework of humanity, going back to Genesis and creation itself.
- If God required at least a tenth from the Old Covenant saints, is it probably, or even conceivable, that He would ask less of us? The only legitimate way to do away with the tithe is to move up to the New Covenant standard of giving everything.
- Tithing should not be approached legalistically, it is something we do by faith because we believe it is the right thing to do and because we trust that God is our provider. If we give willingly and cheerfully, God will see it and return a blessing.
- I believe we should consider it a minimum, a "no brainer," an automatic category in our budget. Giving beyond the tithe is an opportunity to listen to the Spirit of God for His direction in our giving. This kind of giving is sometimes called making "offerings." It is an act of obedience to the Spirit, a spiritual sacrifice that pleases God, and is a function of our faith in God and the generosity of our hearts. We learn the art of generous giving by starting with the tithe and progressing beyond.
- Once you find out that tithing opens up blessings, you will be ready to ask God, "How much do you want me to give beyond the tithe?" Then you will be ready for a really exciting ride!



Disaffiliation Update

On Sunday, 17 September 2023, the Lake Gibson United Methodist Church formally voted to disaffiliate from the denomination. The vote was 66 in favor, 7 against, and 2 abstentions. This will eventually result in our church remaining within the Wesleyan tradition but with a name change. If you grew up in the denomination, there will likely be few changes.

Between now and 2 December, the Church Council will be working to meet administrative requirements necessary for the conversion.

We will apply for a new corporate name of Lake Gibson Methodist Church, Inc.

Change signage to remove the term "United" and logo

Provide past history and records information

Pay a significant exit fee

Acquire a new insurance contract for property and liability

On 2 December a Special Annual Conference will be held were our church and others will be included for proposed disaffiliation. We, and others, should be voted on as a block. If approved, we will be no longer considered a United Methodist Church effective no later than the 31st of December.

Charitable Deductions Can Save You Taxes

Planning may help you reduce your taxes when making contributions to 501(c)(3) tax exempt organizations such as your church. If your contribution comes from either a traditional IRA or through a stock transfer, you may avoid having to pay taxes on that amount. But, the important part is that if this contribution is made as a Qualified Charitable Distribution (QCD), it does not count as income to you in your Federal taxes. These contributions are considered to come from your wealth and not your income.

Effectively, you would maintain the entire amount of your standard deduction (which was doubled in 2018 and is reflected below). You effectively get your standard deduction plus incur no taxes on the amount of your Qualified Charitable Distribution.

The tax items for tax year 2023 of greatest interest to most taxpayers include the following dollar amounts: The standard deduction for married couples filing jointly for tax year 2023 rises to \$27,700, up \$1,800 from the prior year. For single taxpayers and married individuals filing separately, the standard deduction rises to \$13,850 for 2023, up \$900, and for heads of households, the standard deduction will be \$20,800 for tax year 2023, up \$1,400 from the amount for tax year 2022.

Tax brackets for income earned in 2023

- 37% for incomes over \$578,125 (\$693,750 for married couples filing jointly)
- 35% for incomes over \$231,250 (\$462,500 for married couples filing jointly)
- 32% for incomes over \$182,100 (\$364,200 for married couples filing jointly)
- 24% for incomes over \$95,375 (\$190,750 for married couples filing jointly)
- 22% for incomes over \$44,725 (\$89,450 for married couples filing jointly)
- 12% for incomes over \$11,000 (\$22,000 for married couples filing jointly) 10% for incomes of \$11,000 or less (\$22,000 for married couples filing jointly)

What's a Better Tax Break: Charitable Contributions From Stock or an IRA?

Donating from your IRA as a qualified charitable distribution means you won't pay any taxes on the amount donated the same way you would if you took a required minimum distribution as income. But you won't be able to claim the amount as a deduction on your annual tax return (which most of us won't need as we probably use the increased standard deduction).

But making a contribution from stocks may end up benefiting you more in the long run, especially if you held the stock for more than a year and its value appreciates by the time it is donated. This allows you to deduct the stock's full fair market value without having to realize the capital gain.

At What Age Can I Make a Qualified Charitable Distribution From My IRA?

You can begin making qualified charitable distributions from your IRA as soon as you turn 70½. Keep in mind that any QCDs that are generated from your IRA must be limited to amounts that would be taxed by the IRS as ordinary income (monies in a tax deferred traditional IRA and not in a tax-exempt ROTH IRA). Additionally, should you have funds within a 401(k) program, you cannot directly claim a QCD. You must first move those funds you wish to donate into a traditional IRA. Once this is done, you may make a QCD from the IRA.

Other options include:

Charitable Remainder Annuity Trust Charitable Remainder Unitrust Charitable Gift Annuity

Consecration Sunday Is Coming

Congregations that approach financial stewardship from a biblical perspective do not view the money Christians give to their church merely as a way to pay its bills. Rather, such congregations see financial contributions as a way to help people grow spiritually in their relationship with God by supporting their church's mission and ministry with a percentage of their incomes.

Our congregation's finance committee has selected the *Consecration Sunday Stewardship Program* as a way to teach the biblical and spiritual principles of generous giving in our stewardship education emphasis this year.

Consecration Sunday is based on the biblical philosophy of the need of the giver to give for his or her own spiritual development, rather than on the need of the church to receive. Instead of treating people like members of a social club who should pay dues, we will treat people like followers of Jesus Christ who want to give unselfishly as an act of discipleship. Consecration Sunday encourages people toward proportionate and systematic giving in response to the question, "What percentage of my income is God calling me to give?"

During morning worship on Consecration Sunday, we are asking our attendees and members to make their financial commitments to our church's missionary, benevolent, and educational ministries in this community and around the world.

Every attendee and member who completes an *Estimate of Giving Card* does so voluntarily by attending morning worship on Consecration Sunday. We urge people to attend who feel strongly opposed to completing a card. The procedure is done in such a way that no one feels personal embarrassment if he or she chooses not to fill out a card.

We will do no home solicitation to ask people to complete cards. During morning worship our guest leader will conduct a brief period of instruction and inspiration, climaxed by members making their commitments as a confidential act of worship.

We will encourage participation in Consecration Sunday events through the Consecration Sunday team and governing board members. Since we will make no follow-up visits to ask people to complete their cards, we will make every effort to inform, inspire, and commit everyone to attend Consecration Sunday worship.
